### **REPORT AGENDA**

### YEA Update

Julie Hammons gave the update on the YEA stating the fund balance as of December 31, 2022 was \$4.249 million. A couple of large donations were received; One for Rocky Mt. High School to become fully vested and another from a YEA board member. Both were a nice surprise and we are very thankful for the support. Jamborees are currently being scheduled for spring so if you have not scheduled yours yet, please do so.

### Dairy West Update

Ty Jones reported on Dairy West stating the meeting went well. Our concerns regarding the increase of sweatshirt numbers were addressed and we are looking forward to celebrating our 40<sup>th</sup> year of partnership next year.

#### Officials Update

Ty Jones gave the officials update reporting an email was received for Bill Bopp from District 1 stating three major concerns. First and foremost, the sportsmanship of fans and the wording of the 4-3 ejections. The other concerns were the statewide salary proposal (which is on the discussion agenda for this meeting) and the declining number of officials. It was also stated waiving the sign-up fees for first time officials has helped with the number of new recruits.

## Marketing Update

Zach Hoffman was not in attendance due to a business trip but provided the following information for the marketing update. For the 2022 Fall State Championships Dairy West along with the milk crews handed out over 25,000 individual milks and purchased over 4,230 State Champion Sweatshirts for participants. We are working with our two new sponsors this year; Project Filter and the Idaho Department of Highway Safety. Athlete of the Week – presented by Toyota along with Team of the Month – presented by Les Schwab Tires are continuing. You can check the website for more information on these sponsored programs.

## 2022 NIAAA Conference

Ted Reynolds reported the NIAAA conference was held in Nashville, Tennessee this year with a record number of attendances. This is a great conference and very worthwhile. Tol Gropp was selected as the president-elect ~ Congratulations Tol! Julie Hammons reiterated it is a great conference and found the presentation on NIL to be very surprising as well as informative.

## NFHS Winter Meeting

Ty Jones reported the NFHS winter meeting was held in Ft. Lauderdale this year. There were several topics covered including insurance, NIL, and transgender while student mental health was the main focus. Overall it was a good meeting.

## **Trophy Medal Contract**

Julie Hammons reported this is the last year of our contract with Meridian Trophy. We will be negotiating with them on new terms hoping to have everything finalized by July 1.

#### <u>Rule 8-14-1</u>

A motion was made to approve modifying Rule 8-14-1; beginning fall of 2024 as a Final Reading.

8-14-1 Bona Fide Move If the parents of a student, or legal guardian in case neither parent is living, make a bona fide move to a new permanent residence in the attendance area of a school to which the student transfers, he/she is immediately eligible provided an *Athletic Transfer Form* is submitted and approved. A permanent residence is the actual physical relocation by the parents or legal guardians of a student at a new residence and termination of all occupancy of the previous residence. The change in residence must be bona fide and used as the address for utilities, registration for voting, registration for driver's licenses, registration for motor vehicles, identification cards, and the attendance zone for other school aged family members for a minimum of 365 days. For the purpose of eligibility, there can be only one residence.

<u>Move Less Than 50 Miles</u> If the parents of a student move less than fifty miles from their present residence, the follow information must accompany the Athletic Transfer Form:

- 1. Letter from parents explaining the move.
- 2. Letter of support from school filing the request.
- 3. Proof of former residence address being terminated (lease termination letter, escrow closing papers).
- 4. Real estate documents indicating and verifying the valid change of residence OR proof of entering a long-term lease (minimum of 12 months).
- 5. Proof of at least two utility services/monthly bills in the family's name at the new residence address **AND** documentation of termination of the same at the former address (cell phone, auto insurance, pay stub, gas, water, electricity, cable TV, etc.)
- 6. Proof of change in address on the parent(s) and age-appropriate student's driver's license to new residence address.

The IHSAA Executive staff or Board of Directors may approve or deny varsity competition if circumstances warrant.

## <u>Rule 3</u>

A motion was made to approve adding language to Rule 3 regarding coaches that are not certified to teach as a Final Reading.

All new coaches that are not certified to teach in the State of Idaho, must take the NFHS Teaching and Modeling Behavior course, prior to the first day of practice. This course would only be required upon being hired in Idaho for the first time.

#### **RULE 6 - CONTRACTS**

- 6-1 The Interscholastic Activities Contract must be used to arrange varsity contests in football, volleyball, soccer, basketball, and wrestling. The principal or activities director of each school must sign the contract. When a school has two or more teams competing in the same sport, the teams must be clearly designated as "first", "second", or "third" team. (See contract form for additional information.)
- 6-2 If the contract is breached by either party, the IHSAA Board of Directors or District Board of Control, whichever is appropriate, will determine reasonable damages to be paid to the contracted opponent by the school that breaches the contract. In no case will the damages exceed three times the Association annual membership fee. The Board will not review oral contracts.
- 6-3 Contracts may be cancelled by mutual written consent of the contracting schools.
- **6-4** The Board of Directors may cancel any contest or contract if the Board determines that the contest should not be held because of death, fire, flood, disease, abandonment of an activity, or other reasons of impossibility of performance. No contest shall be ruled a forfeit until the Board has reviewed the facts of each case.


### ARTICLE VII.

### COMMITTEES


Section 1. Executive Committee. By resolution of the Board of Directors, three (3) or more members of the Board of Directors may be elected to serve as an executive committee or executive committees of the Board of Directors. The executive committee or committees shall have and exercise the authority and powers granted to it or them by resolution of the Board of Directors, and, by such resolution, the Board of Directors may vest in an executive committee all or any part of the power and authority vested in and held by the Board of Directors by the Articles of Incorporation, these By-Laws and the statutes of the State of Idaho. An executive committee shall meet at such time and place and upon such notice as shall be provided by it in a resolution spread upon its minutes and shall keep minutes of its proceedings and at each meeting of the Board of Directors shall report its actions and activities. A majority of an executive committee shall constitute a quorum for the transaction of any business that the committee has power or authority to transact.


Section 2. Special Committees. The President shall have the authority to appoint special committees to perform particular functions for the Board of Directors as may be designated by the President. The number of members appointed to serve on special committees shall be discretionary with the President. Special committees shall not have authority to bind the Board of Directors or the Corporation but shall act only in an advisory capacity.

Section 3. Eligibility Committee. An eligibility committee, consisting of at least three (3) directors, shall be appointed by the Executive Director. More than one such eligibility committee may be appointed and a director may serve on more than one such committee. A majority of the committee shall constitute a quorum. An eligibility committee shall have the authority to hear and consider applications for approval of eligibility and waivers of eligibility under the Association's rules and regulations. A committee shall record the action taken on each application. A committee decision shall be a decision of the Board subject to review upon request of the applicant.

## \*A region cannot host two years in a row unless both schools are from that region.

The final decision in setting sites, dates and time for each state championship game will be made by IHSAA Representatives and will be finalized by 10:00 a.m. the Sunday prior to the state championship game.

Selection Criteria:

A. Factors determining the site of a state championship game are:

- 1. Idaho State University There may be at least three games, and possibly four, scheduled at Holt Arena. Two games should be scheduled on Friday. The remaining game or games will be scheduled on Thursday or Saturday, with times to be determined by ISU's football schedule.
- 2. University of Idaho There may be a maximum of three games per day scheduled at the Kibbie Dome. If possible, games should be scheduled for Friday afternoon and evening. Game times and dates will be determined by U of I's football schedule.
- 3. Boise State University There may be two games per day played at Dona Larson/ Albertsons Stadium. Game times and dates will be determined by the Boise State football schedule.
- B. Other factors determining the site of a state championship game are:
  - 1. Travel loss of instruction time for the two participating teams.
  - 2. Geographical rotation based upon recent participation of the district from which the teams are participating.
  - 3. A region may not host a state championship game two years in a row unless both teams are from the same region
  - 4. If No. 2 and No. 3 are in conflict with each other, No. 3 will take precedence over No. 2.
  - 5. Availability of lodging and meals for teams, support groups and spectators.
  - 6. Availability of the site to set reasonable game times. No game may be scheduled to start after 9:00 p.m. The team traveling the farthest distance will get first choice of game time.
