REPORT AGENDA

YEA Update

Julie Hammons reported on the YEA stating not a lot to report. We had a great fall jamborees season and are still waiting for quite a few schools to report earnings. We have some winter jamborees scheduled but numbers appear to be down from previous years. The next YEA Board Meeting is scheduled for October 16th and 17th in the Boise area.

Dairy West Update

Ty Jones reported on the Dairy West meeting and stated they are in the process of updating our contract. A few items of discussion included the milk crews and some changes they will be making with distribution along with merchandise rights and potential bidding processes. This will be our 39th year with Dairy West and they continue to be a fantastic sponsor.

Officials Update

Ty Jones reviewed the officials update provided by James Bolen from District 6. The few items of concern included possibly revising Rule 4-3, instructions/guidelines for shot clock operators and the new officiating platform, Dragonfly. All of these concerns have been discussed and will be addressed.

Marketing Update

Ty Jones reviewed the marketing update provided by Zach Hoffman, General Manager of IHSAA Sports Properties. Zach is currently working on securing a new corporate sponsorship with the Idaho Department of Highway Safety while renewing sponsorships with Department of Health & Welfare and finalizing a contract with the Army National Guard. He is also excited to be able to provide the sponsored programs again this year; Athlete of the Month presented by Toyota and Team of the Month presented by Les Schwab Tires. Zach also continually promotes Unbottled for Dairy West.

Section 7/8 Conference

The Section 7/8 conference was held on September 18-20, 2022 in Kaua'I, Hawaii. Board member, Tim Perrigot attended along with Ty Jones and Mike Federico. Tim reported it was a great conference and he was impressed how the Idaho office is very well known and respected. Many of the challenges we face are the same across the states such as classification and team travel. It is such a valuable tool to be able to meet and collaborate with the other states.

Administrative Workshops

Ty Jones reported the administrative workshops are complete and went well.

Media Days

Mike Federico reported Media Days went well and is very beneficial to our office to be able to maintain a working relationship with the local media. He was able to meet with over 45 media members throughout the state going over our rules, procedures and answer any questions. Creating a media protocol document for our school media kids was suggested which would include the basic media dos and don'ts at state events. This document will be sent out with requested passes to our member schools and is asked to be shared with any and all individuals using the media passes.



Match Limitations

No team (any level) or individual may wrestle more than 16 dates during the regular season. A team or individual can compete in a maximum of six tournaments. A tournament is defined as competing against four or more schools. When a wrestler competes in a dual match tournament, the competition is counted as a tournament even if the individual only wrestles one match. Friday after 3:00 p.m. and Saturday may count as one date and one tournament. A two- day tournament starting prior to 3:00 p.m. on Friday will count as two of the sixteen dates, but only one tournament. All other competition shall be counted separately. Each day of competition will count as one of the sixteen dates.

A team may substitute one additional one-date tournament for two dates. A school wrestling in seven one-date tournaments may only wrestle on 15 dates. A team or individual may compete in a maximum of eight tri-matches.

A contestant who exceeds the limitations of regular season participation will become ineligible for district, state or any other additional IHSAA sponsored competition of that sport.
