#### CONSENT AGENDA

Chad Williams presented the financial report, noting that the fiscal year ends at the end of the month. He reviewed the current revenue budget percentages and highlighted several key areas. Interest and dividends are up over 1,000% due to strong investment performance. Volleyball is currently at 62% of the revenue budget, which is lower due to the reimbursement method used by Mountain America. Cross country came in at 218%, having performed very well, and swimming also exceeded expectations thanks to additional spectator seating that increased fan capacity. Baseball had a successful first year, generating approximately \$100,000—62% more than budgeted. Broadcasting and ticketing came in at 121%, as NFHS projections were exceeded (Pages 16-19).

Chad reviewed the expenses, beginning with the miscellaneous category, which is at 643%- largely due to a \$30,000 hotel bill paid this year for a charge from last spring. Website expenses were higher than normal because the outdated concussion video, which hadn't been updated in 10 years, which was replaced shortly after Chad began. The rule books expense line is at 59%, reflecting cost-saving measures implemented by Riley Jones to streamline the distribution process. The Interscholastic Star/SAC expense line is currently at 50%, as scholarship funds have not yet been disbursed. Overall, the organization is currently \$16,513.36 in the black, and even after settling a few remaining bills, it is expected to remain in a positive financial position.

A motion was made to approve the consent agenda which included the Balance Sheet and Financial Report from July 1, 2024, to May 31, 2025.

## **REPORT ITEMS**

## **YEA**

Julie Hammons provided an update from the spring YEA meeting held in May. She shared that the fund balance is currently at \$5.2 million, which is a strong position. The hope is that this amount will hold or improve by June 30<sup>th</sup>, at which point disbursements will be determined based on the fund balance on that date. Of the disbursement total, 3.5% will be allocated to schools based on participation in the nine tournaments included in the YEA disbursements. The additional 0.5% will be distributed equally to all fully vested schools. The YEA board also determined that jamboree revenue will be split evenly between the participating schools, with 50% going to fully vested schools as part of their end-of-year disbursements, while the remaining 50% will be directed toward helping the participating non-vested schools move closer to full vestment.

A new donation idea was also introduced: Qualified Charitable Distributions. This program is designed for individuals of retirement age who are required to take minimum distributions from their 401k accounts. By donating those distributions directly to a qualified charity, individuals can avoid raising their taxable income. The YEA hopes to use this program as an outreach tool for individuals who are interested in supporting the program.

## **PlayFly**

Morgan Potter provided an update on current contracts, announcing that Baden is now the official ball sponsor for soccer, volleyball, basketball, and softball. She also shared that the merchandise contract with MCU Sports has been renewed. Both agreements are five-year contracts.

#### Officials

Chad Williams reported that he recently met with the officials, but there are no new updates to share at this time.

## **Board Committees**

## • State Tournament

 2026 Track Proposal- Chad Williams reported that the State Tournament Committee reviewed and discussed several proposals that were presented; however, no final decisions were made (Pages 20-23).

A motion was made to form a committee to review all submitted track proposals, with the goal of combining them and potentially reconfiguring the structure of the state meet.

#### Motion carried

Over the past few years, the number of qualifiers has grown significantly—nearly double that of the 4A classification—making it increasingly difficult to manage a state tournament. Matt Harris presented

a proposal to the board to address the issue. He explained that the classification may have reached a saturation point, where the volume of participants is becoming unmanageable for tournament hosts and golf courses. One potential solution discussed was splitting the classification into two. Harris noted a natural divide in school numbers between the 3A and 2A levels that could serve as a logical point for reclassification. His intent was to initiate the conversation and bring attention to the issue at the state level (Pages 24-25).

It was recommended to take a year or two to work with golf courses and gather data on the number of individual golfers compared to the number of teams. The goal would be to explore splitting the 3A and 2A/1A tournaments for adoption by the spring of 2027.

o **Future Baseball/ Softball Sites-** Mike Federico discussed the upcoming State Baseball and Softball sites, mentioning a proposal to move state baseball games from Orofino. This topic will be addressed further during the action agenda.

Julie Hammons also noted potential issues with the scheduled softball sites for the upcoming year. Currently, tournaments are set to be held in Orofino and Moscow, which presents a conflict due to the University of Idaho and LCSC graduations taking place the same weekend. She mentioned that the 2A tournament may remain in place, as it only involves six teams, but the 3A tournament will need to be relocated. Timberlake High School is a possible host for the 3A division, but she is actively working to secure a new state softball site in either District II or District I.

o **Tennis Seeding Proposal-** There were three proposals for the committee to review regarding how the classifications are seeded (Pages 26-28).

A motion was made to approve the first tennis seeding proposals for a First Reading with modifications as needed.

- O Girls Wrestling Proposal: Twin Falls- Chad Williams reported on the girls' wrestling proposal presented by Twin Falls High School. He stated that the Girls' Wrestling Expansion Committee has already reviewed a similar proposal. No action was taken.
- o **Memorial Awards Selection-** Julie Hammons reported that the votes have been tallied and will be announced later in the meeting.
- o Budget FY26

The Budget Committee reviewed the fiscal year 2026 budget and noted that it is over \$3 million.

## **Contracts**

- PlayOn
  - o **GoFan-** Chad Williams discussed our contract with GoFan, the company we use for ticketing. The service they provide is reliable and we enjoy working with them. This topic will be addressed later.
  - o **NFHS Network-** Mark Koski, Chief Marketing Officer of the NFHS Network, gave a presentation to the board providing an update on the Network's direction as well as educating them on its functions. Chad noted that customer service is a strong point for NFHS and that they are actively working to improve it further. Revenue from the NFHS Network is growing significantly and benefiting both us and the schools. PlayOn, the leading company in this space, has merged with GoFan, NFHS Network, and MaxPreps. As these entities continue to integrate, it is expected to benefit us, and we will receive more information on how this will support the schools.

## 2025 NFHS Legal Meeting

Chad Williams reported on the 2025 NFHS Legal Meeting and emphasized the common goal discussed across all states, was providing opportunities for kids. He mentioned discussions about legislatures becoming involved with transfer rules and highlighted that other states are facing similar issues. He stressed that the purpose of transfer rules is to create a level playing field. Overall, he said the legal meeting was a success, and he gained valuable insights.

## **School of Excellence: Final Standings**

Julie Hammons reported on the Schools of Excellence awards that were announced last week and congratulated all of the winners. She noted how close the point totals were, with only a six-point difference between the top two 5A schools out of 5,000 possible points. She expressed pride in the program, saying it truly highlights what high school sports and activities are all about. She encouraged administrators to review the standards and use them to boost school camaraderie and spirit. The Schools of Excellence plaques will be presented at the annual meeting on August 6<sup>th</sup> at 1:30 PM (Pages 29-35).

## **2025 Administrative Workshops**

Chad Williams reported that the Administrative Meeting schedule has been posted on the website and encouraged everyone to review it.

## Media Days

Mike Federico reported that the 2025–2026 Media Days have been scheduled and are available on the Media page of the website. These meetings provide an opportunity for mainstream media members to connect with IHSAA staff, discuss rule changes, and stay informed on current developments. The goal is to ensure accurate and up-to-date information is shared. Media credentials will also be available for pickup at the event.

## **2025 Spring Concussions**

Chad Williams reviewed the spring concussion data and noted that while some trends are present, this year's numbers are lower than in previous years. He also shared that schools could request their individual data if they would like to review their trends over the years (Page 36).

#### 2025 State Golf

Julie Hammons reviewed State Golf and commended Stacy Wilson and Jennifer Murdock for doing an excellent job hosting the state tournament. She also reported on the financials for State Golf, noting that there is currently no revenue generated. While other states are able to make money from their state golf events, Idaho does not. Currently, golf courses are only paid \$1,200 for the three-day tournament.

The idea of charging for parking, similar to what is done at cross country events, was discussed as a possible way to generate revenue. Julie mentioned that any revenue collected would not go to the IHSAA but would instead go directly to the golf courses. She plans to attend the golf meetings at the upcoming NFHS summer conference to explore potential strategies other states use to bring in funding.

## 2025 State Softball

Julie Hammons reviewed the financials for State Softball, noting that inclement weather created additional challenges. She commended the managers for doing an excellent job despite the conditions. Larry Taylor hosted at Quad Park in Caldwell but reported that the site presented difficulties due to limited amenities. As a result, alternative venues are being considered for future tournaments. Julie and Tonia have met to discuss potential options and are also reviewing a letter from District VI regarding the matter.

#### 2025 State Baseball

Mike Federico reported on State Baseball, noting it was the first year under IHSAA and included a change in format. This is part of a two-year pilot, so there's one more year to go. Feedback has been gathered from those involved, and adjustments will be considered moving forward. There were 20 play-in series held across the state, which presented some challenges given that it was a new process. Mike noted that host sites generally performed better financially than neutral sites and suggested this could be considered for play-in games in other sports. Overall, the play-in sites generated nearly \$19,000 in revenue. While some expenses and revenue are still being finalized, the championship series went well. Mike thanked the managers for working hard to manage onsite costs. Overall, it was a successful first year of sanctioning State Baseball.

- MaxPreps Reports-He reviewed the MaxPreps rankings for both the play-in and championship series. The goal was to feature the best matchups in the championships. The tournament was structured to give higher-seeded teams an advantage while also reducing travel distances for schools. Sites were spread across the entire state and included every classification, allowing new schools the opportunity to host. The data showed that if the top eight seeds were taken, only one number eight seed failed to advance to the series. The "if necessary" games were challenging, but 17 of the 20 top four seeds made it to the championship series. Out of 52 teams, 20 traveled outside of their local area. However, securing hotel accommodations was difficult, and this is an issue that needs to be addressed. Regarding back-to-back weekend travel, only one team experienced that.
- **Pro's & Cons Report-** He discussed a pros and cons list he prepared, which is provided below for review. One notable point was that this was the first tournament besides football to allow team entry through MaxPreps. However, two districts added games after their district championships to improve their MaxPreps rankings. This was an unforeseen situation that will be addressed to prevent it from happening in the future. Overall, the tournament worked the way the committee designed it (Pages 37-38).

#### 2025 State Tennis

Mike Federico discussed State Tennis, noting that due to significant rain on Saturday, all matches were moved indoors. Expenses remained consistent overall; however, the bill from BOAS is still outstanding and is expected to be substantial. The Band App was heavily utilized for communication with parents and coaches and performed exceptionally well. Tennis Reporting reported there were approximately 10,000 views on Friday and 14,000 on Saturday for the live scoring, which suggests "real time" scoring could be beneficial for other sports as well. Trainer expenses increased by about \$3,500, as trainers were available each day of the tournament. Additionally, officials were assigned to every site throughout the tournament. There was discussion about the possibility of moving the tournament to Monday and Tuesday, in order to alleviate some of the congestion and scheduling challenges caused by the number of events taking place that weekend.

## 2025 State Track

Chad Williams reviewed the State Track financials, noting that gate revenue was up this year despite the weather. This increase may be attributed to the \$1 ticket price increase. Historically, the state track meet operates at a loss due to the large number of personnel required to run the event. One recurring topic has been the pole vault event at Middleton, which in past years has extended into the night. This year, Andy Ankeny ensured proper lighting was available, though the event did not run late. Additional discussion will be needed to find a long-term solution. Additionally, the running event schedule at Middleton was adjusted to begin earlier on Friday, which received positive feedback.

Chad Williams provided an update on enrollment numbers. He noted that the yellow-highlighted data represents information that has not yet been submitted, but it is not expected to impact classifications or result in any changes (Page 39).

## **Student Advisory Council**

Mike Federico provided an update on the 2025–26 Student Advisory Council. There are 15 returning members and 11 new members; however, there were no applicants from District 1. The SAC aims to have two juniors and two seniors from each district. The returning seniors met last week to establish priorities and goals for the upcoming year. One of their main objectives is to conduct fall outreach to engage more students and promote student engagement. The SAC retreat is scheduled for the end of July, during which the students will work on their goals and plan their participation in upcoming Admin Meetings. Samantha Parsons from Payette will serve as the SAC President for 2025–26.

#### **Star Award Selection**

Mike Federico discussed the Interscholastic Star Awards, which highlight the best of the best in academic-based activities, community service, and leadership. This year, there were 56 applications, and six students, one from each classification, were selected as Star Award winners. Each recipient receives a banner, trophy, cash award, and a monetary award for their school. Gracie Ford from Lake City High School was named the overall Interscholastic Star and will speak at the Hall of Fame Banquet. Her photo and story will also be featured on the back of next year's program.

## Eligibility Waiver Data

Chad Williams presented hardship data from the past four years, highlighting the various approval percentages and noting how few cases are actually denied. He emphasized that the board makes every effort to allow students the opportunity to participate whenever possible.

## State Wrestling in Moscow

Chad Williams and Shawn Tiegs met with representatives from the University of Idaho to discuss ticket and security costs. According to those with authority, the changes are expected to move forward. Chad recommended keeping the item at final reading and completing the process at the August meeting. Shawn added that the positive aspect of the new ticketing arrangement is that it will apply to all activities hosted at the University of Idaho, not just wrestling, which should help with pricing for volleyball and football as well.





Mike Federico noted that for 2A and 6A baseball, multiple sites are listed on the calendar, with backup sites designated depending on the number of teams qualifying from the same district. If all qualifying teams come from the same district, travel for those teams can be minimized (Page 40).

• 5A State Soccer - requested information- Julie Hammons shared feedback that was requested from Sandpoint regarding their ability to host State Soccer. The community believes there are ample facilities to support the event. While acknowledging the significant travel involved, the entire city is enthusiastic about hosting. Play-in games will be held at the Field of Dreams, with both the boys' and girls' state championship games taking place back-to-back at the large stadium by the lake.

## Wrestling Proposal 1 Rule Change

A motion was made to approve the Wrestling Proposal 1 Rule Change with modifications as needed as a Final Reading.

#### Proposed: Wrestling Rules & Regulations

"To be eligible for district and state competition, each wrestler must weigh in at scratch weight and be available to compete on three of the sixteen regular season dates. The coach must provide verification that the wrestler has met the three required weigh-ins before the <u>district</u> seeding meeting. Each weigh-in will count toward one of the <u>wrestler's</u> sixteen regular season dates."

#### Current: Wrestling Rules & Regulations

"To be eligible for district and state competition, each wrestler must weigh-in at scratch weight, then compete at scratch weight, or up one weight above scratch weight, on three of the 16 regular season dates. The coach must be able to provide verification that any wrestler has made the three required weigh-ins before the seeding meeting. One may only count weigh-ins conducted at meets in which your school participates."

## Rule 2-5-3b: MaxPreps Fine

Mike Federico discussed two key changes. First, language was added to clarify the use of Pacific Standard Time. Second, the Board asked to explore the implementation of a fine for schools that fail to enter their data by the deadline. Alisa Dancer, our MaxPreps contact, noted that she can print a report identifying which schools did not submit their information, and those schools would be subject to a \$1,500 fine. This fine will not impact rankings but is intended to encourage timely data submission.

Julie Hammons mentioned that the requirement will apply only to team sports, as individual sports cannot be verified in the same way. One challenge is that games not appearing on MaxPreps could still be missed. New guidelines will be developed, particularly regarding forfeits, and that information will be shared during the upcoming administrative meetings.

A motion was made to approve the Rule 2-5-3b: Max Preps Fine with modifications as needed for Final Reading.

#### 2-5-3b: Proposed

b. All regular season and district tournament game scores must be entered by each member school on MaxPreps by midnight, Pacific Time, on the Saturday preceding the state tournament. Schools that fail to meet this deadline will be fined \$1,500 per sport. Any scores submitted or modified after the deadline will not be included in the final rankings.

#### 2-5-3b: Current

b. Regular season and district tournament game scores must be posted by each member school on MaxPreps prior to midnight the Saturday prior to the state tournament. Scores posted and/or altered after the Saturday deadline will NOT be included in the final rankings.

• **Spirit of Sport-** These nominations can come from a variety of individuals, typically from schools. The recipients are often current coaches or players who have faced adversity and demonstrated how the spirit of competition helped them rise above it.

Winner: Bennet Smith, a student from Fruitland High School.

• **Dick Fleischmann Memorial** - This award is given to recognize individuals who manage state tournaments and help with playoffs.

Winner: Robert Parker, Pocatello High School Athletic Director.

• Wes Lowe Memorial- For administrators and coaches who understand the value of education-based activities and are dedicated to teaching lifelong lessons to students through activities.

Winner: Tim Chapman, Shoshone High School Athletic Director

• **Duane D. Wolfe-**This award recognizes individuals and groups outside of the school community such as businesses, boosters, and volunteers, who generously donate their time and resources.

Winner: Earl Vicory, longtime volunteer at Orofino High School.

#### ACTION ITEMS-FIRST READING

## Regular Membership Requirements

Julie Hammons discussed how, over the past few years, new schools have joined the IHSAA but often don't fully understand the structure of the IHSAA or its requirements. She emphasized that it's in these schools' best interest to first join as associate members, allowing them to familiarize themselves with all the requirements. While district expansions might request a bypass, individual schools need to follow this process to ensure proper understanding and compliance.

A motion was made to approve the Regular Membership Requirements Proposal with modifications as needed as a First Reading.

#### ARTICLE I. MEMBERSHIP

Section 1. A. Regular Members. Any public or private school within the State of Idaho that meets the accrediting standards of secondary schools as required by the State Board of Education and facility and program requirements for interscholastic competition as outlined by the IHSAA Board of Directors is eligible to become a regular member of the corporation. In order to become a regular member of the corporation. as an associate member for two years, or b) request permission to apply for direct regular membership from the IHSAA Board. Application for membership by schools in the State must be approved by a two-thirds vote of the Board of Directors as a Final Reading at the January IHSAA Board. of Directors meeting the school year prior to membership.

All applicants for regular membership in the IHSAA must meet the following facility and program requirements.

- Facility Requirements
  - Demonstrate the ability to host competition and provide a safe and appropriate environment for those activities the school chooses to sponsor.
  - Demonstrate the ability to meet the following field and gym conditions:
    - Meets National Federation field/court specifications (ex. size, length, ceiling height)
      Playing surface safe and adequately maintained, properly marked

    - Crowd control capabilities (Security barrier)
  - Demonstrate the ability to meet the following facility amenities:
    - Adequate spectator seating/viewing area
    - Available restrooms
    - Score boards public address system when needed
    - Crowd control management
    - Adequate locker room for visiting teams
    - Adequate team areas (sideline benches, etc.) Adequate parking for visiting team buses and spectators
- 2. Program Requirements
  - Schools seeking membership in the IHSAA that are established for the purpose of selecting students on the basis of skills and technique in an IHSAA-sponsored activity would be ineligible to compete against member schools in that activity.
  - Associate Members. Schools not meeting the State Board of Education accreditation standards are eligible to become associate members of the corporation. An associate member shall have the same privileges as a regular member except that it shall have no right to vote, shall not be entitled to participate in district or state tournaments, and shall not be entitled to championship awards.
  - With the payment of annual membership dues to the corporation, both classes of members agree to subscribe to the by-laws, rules and regulations promulgated by the corporation.

## Middleton Girls Basketball Request

Middleton High School's Girls Basketball team submitted a request to compete at the 6A level for the upcoming year. The rule requires superintendent approval, and the request received strong support. Andy Ankeny, Middleton's Athletic Director, discussed how the previous season was challenging because the team was winning by extremely large margins, which he felt was not beneficial for either team involved (Pages 45-46).

A motion was made to move the Middleton Girl's Basketball Request to a Final Reading with modifications as needed.

Motion carried 14 Approve, 1 Deny

### **DISCUSSION ITEMS**

- 1. Classification Committee Priorities- Chad Williams discussed the classification petitioning timeline, noting that the current window is too short and needs improvement. He mentioned that the Board has given him direction to form a committee to address this issue. The bullet points he shared highlights key ideas for consideration, and he asked the board to prioritize these topics to guide discussions with the committee.
  - Enrollment
  - Participation numbers
  - Socio economic status
  - Extended boundary school multiplier

Some points raised for prioritization included whether schools that win a certain number of championships consecutively should be required to move up a classification, the importance of maintaining competitiveness, and the potential use of a multiplier for schools with extended boundaries, such as charter or private schools. Discussion also covered considering an out-of-district enrollment multiplier and the need to balance classification sizes. The topic will stay on the Discussion Items for the next meeting to provide another opportunity to review the priorities.

2. Transfer Rules- Chad Williams formed a transfer rules committee with two representatives from each district, one from a large school and one from a small school, in response to HB 237. During the first meeting, objectives were set, and the committee was tasked with reviewing transfer rules from another state. At the second meeting, legislative members were invited, and the committee reviewed additional information about transfer rules from other states. By the third meeting, the legislative members had gained a clearer understanding of the committee's perspective based on their research. Legislators indicated that the rules should change but did not specify how. During that meeting, the committee discussed every possible idea from various states. Then, last week, the committee met again and began narrowing down the points they agreed on regarding transfer rules.

Chad explained that the committee agreed there still needs to be a bona fide move requirement and a hardship process. They also agreed that eligibility should be automatic upon transfer, noting that very few transfer requests are actually denied. Since students already choose their school as freshmen, the idea was floated to allow transfers in any year, potentially with penalties attached, such as a postseason ban. The committee was tasked with gathering input from their constituents to help decide direction and bring a proposal forward in September. It was noted that postseason bans can be lifted through restraining orders, so that option might not be effective. No action taken at this time.

3. Play-off Format Agenda, Committee Proposals, Survey Results- Chad said the playoff committee has met several times and distributed a survey with three proposals for the schools to vote on. The results were compiled into a spreadsheet, with each proposal rated on a scale of 1 to 5. He noted that everyone who voted in District 3, as well as the 6A group, ranked the 40% bracket proposal last, while all other voters ranked it as their first choice. The 6A group created their own proposal, which sparked a lot of discussion regarding classifications being able to create their own proposal (Page 47).

A motion was made for a substitute motion to advance the 40% bracket proposal as the new play-off format for 1A-5As as a First Reading with modifications as needed.

A motion was made to advance the 40% bracket as the new play-off format for all classifications as a First Reading, with modifications as needed.

Motion carried Approve 12, Deny 3

- **4. IHSAA Goals** -The IHSAA directors reviewed last year's goals and stated they feel those goals were accurately accomplished. Chad asked for feedback on the new goals set that are listed below, or suggestions for new goals in the future. No action was taken.
  - Update classification timeline
  - Begin visiting in person the 171 members schools
  - Attend district superintendent, principal, and activities director meetings.
  - Technology Implementation
    - o Officials' cards
    - o Cooperative applications
    - o Special request: Jerseys, Rule 12, Medical
- 5. Sportsmanship Awards Criteria- Tonia Burk discussed that the Schools of Excellence criteria currently do not include softball and baseball in the sportsmanship component. She proposed integrating these sports into the program. The plan would mirror other state tournaments by awarding a T-shirt to a fan from each participating school who demonstrates good sportsmanship and presenting a plaque to the team that displays the best sportsmanship. She added that softball umpires are in support of this addition and believe it would be a very positive initiative.

A motion was made to move the Sportsmanship Award Criteria for softball and baseball to a First Reading with modifications as needed.

**6. 100 Year Celebration-** Julie Hammons noted that the 2025-2026 school year marks the IHSAA's 100-year anniversary. She shared that other states have celebrated similar milestones with festivities such as commemorative logo banners, swag, books, and pins. The question was posed to the board about how they would like to celebrate the anniversary. However, it was noted that no funds have been allocated for this in the current budget.

A motion was made to have the president put a committee together to come up with ideas for the 100-year celebration.

Motion carried

# Proposal to the Idaho High School Activities Association (IHSAA) for Track & Field Format and Qualification Changes

Submitted by: Aaron Olswanger, President of the Track & Field/XC Coaches Association

**Date:** April 23<sup>rd</sup>, 2025

#### Overview

This proposal outlines three recommended changes to the Idaho State Track and Field Championships format, based on extensive feedback from coaches across the state. These recommendations aim to enhance competitive fairness, improve athlete experience, and ensure compliance with federal regulations.

A statewide poll conducted among high school track and field coaches across Idaho gathered 109 responses, representing approximately **78% of the schools** statewide. The results demonstrated overwhelming support for the following proposed changes:

## 1. Extension of the State Meet to a Three-Day Format

#### **Current Issue:**

The current two-day schedule places a significant burden on student-athletes, especially those competing in multiple events. It compresses competition, leading to limited recovery time, increased risk of injury, and a diminished spectator experience.

#### **Poll Results:**

85.3% of coaches support transitioning the state meet from a two-day to a three-day format.

#### **Recommendation:**

Extend the Idaho State Track and Field Championships to three days. This would allow for:

- More balanced event scheduling
- Adequate recovery time between events
- Enhanced athlete performance and safety
- Improved meet logistics and spectator experience

## 2. Standardization of the Medley Relay Distance for Title IX Compliance

#### **Current Issue:**

Currently, the boys and girls medley relay events are run at different distances, which creates a disparity that potentially violates **Title IX**, a federal law prohibiting sex-based discrimination in federally funded educational programs and activities.

#### **Poll Results:**

74.7% of coaches in classifications 2A–5A support running the **same distance** for both the boys and girls medley relay.

#### **Recommendation:**

Standardize the distance of the medley relay for both boys and girls to ensure equal opportunity, fairness, and full compliance with Title IX regulations.

## 3. Increased Representation at the State Meet

#### **Current Issue:**

Many deserving athletes and performances are excluded from the state meet under the current qualification system, limiting opportunities for broader representation and competition.

#### **Poll Results:**

83.5% of coaches support expanding state meet representation by implementing automatic qualifying standards and/or including the next 8 best marks per event across classifications.

#### **Recommendation:**

Revise the qualification system for the state meet to include:

- Pre-established automatic qualifying standards per event
- The next 8 best performances statewide in each event, regardless of district or region

This change would elevate the quality of competition and reward top-tier performances from across the state.

### **Conclusion**

These recommendations are grounded in a significant majority of Idaho's track and field coaches. Implementing these changes would:

- Align Idaho with evolving best practices in other states
- Enhance the experience and fairness for all athletes
- Demonstrate the IHSAA's commitment to safety, equity, and excellence in high school athletics

We respectfully urge the IHSAA to give these proposals serious consideration and initiate the necessary steps to implement them ahead of the 2026 track and field season.








2A, 3A, 4A, 5A Divisions Only (continuation from Q3): Which Medley would you prefer if this were passed?

# From TJ Gomez, former coach and longtime PGA pro, host of 3A 2026 State Tournament:

- 1. This year at Burley ran a lot smoother than last year at Circling Raven. A lot of last year's circumstances were due to the golf course not opening itself up until 12noon. We all knew that was going to be a problem before the tournament even started and that situation ended up causing a lot of negative sentiment from everybody involved. Having this year's times starting at 8:30am made a significant difference to the positive. Going to 8 minute intervals on tee times also helped. We hardly had much of a wait at the turn on Day 2 and the #1 tee box barely had any wait at the turn on Day 2. Bottom line: this year's setup and situation had the opposite effect to the positive from everybody who was involved.
- 2. When golf courses are willing to start the event in the morning like that and allow front/back starting times the vast majority of problems simply go away.
- 3. Trying to secure golf courses is very simply getting harder and harder. Even for courses that are making real money hosting a corporate scramble or something along those lines. It's always a delicate balance between closing your golf course and keeping it open enough days to satisfy regular clientele.
- 4. I've got real life examples about my hesitation in the efforts to secure a 3rd golf course in a given area to host another state event simultaneously. We were at Burley in the fall of 2024 for Districts and State and Burley hosted Districts and State again this spring. I hosted Districts in Mountain Home for Compass Charter in the Spring of 2024 because they had a hard time finding a course in the Boise area to host. I hosted Districts for Centennial High in the fall of 2023 because they had a hard time finding a course in the Boise area to host. I'm going to host Districts for Kuna High this coming fall at Scotch Pines GC because they're having hard time finding a course in the Boise area to host. That's 3 events being hosted, in either Mountain Home or Payette at Desert Canyon GC and Scotch Pines GC, by schools that aren't otherwise associated with those particular golf courses simply because schools are having a hard time and those examples are only pertaining to a one day district tournament.
- 5. If 3A is broken off I think the quality of field will suffer too much. If a change is made I'd suggest having a completely separate event for boys and girls and keep 3A/2A/1A together. You'd solve your numbers problem by running separate events and maintain nice integrity with the event by keeping a higher quality of field utilizing those 3 classifications as one all simultaneously. 4A field seems fine both in size and overall quality of player.
- 6. My 1st vote and suggestion would be to leave it alone simply because I think it'll be too difficult and too stressful to have 3 sites going all at the same time. Depending on where you're going it may not even be feasible. Having said that, I do understand that 140 kids is a lot for one property so if a change is made I'd break off the girls and the boys and let them each have their own event. Lots of programs run separately anyways with all kinds of variations of schools qualifying for state so I don't think having boys at one host site and girls at another host site would feel much different in the eyes of the players and parents.

#### From Matt Harris, Ririe AD:

I have a few other thoughts to share on this:

- 1. The number of volunteers required to run this small-school tournament is roughly double the needed to run the tournament in any other classification. Splitting the classification would shrink the number of teams/individuals in the field and also shrink the number of volunteers needed.
- 2. The number of tee times needed would also shrink if we split the classification. We had 38 groups this year. That's 38 individual tee times. We would be looking at 19-20 tee times max if we split it.
- 3. There may be some schools in 1A/2A who may not start a golf team because they have to play in the 3A classification. I don't have any evidence that this is the case, however I do know that it could be a factor because it is a factor for my own school (Ririe) when it comes to soccer. We don't have a soccer program because we would have to play in 4A which is a losing proposition for us.
- 4. Here are this year's participation numbers at the 3A State Golf Tournament

Girls - 64

Overall - 139

## **Classification Guidelines**

In the scenario where a school/player qualified for state at a different classification the previous year, the previous state experience seeding criteria will be followed in this order:

#### Singles:

- Qualifications #3-#4 (medal winners): Higher classification
- o Qualifications #3-#4 (medal winners): Lower classification
- Qualifications #5-#6: Higher classification
- Qualifications #5-#6: Lower classification

#### Doubles:

- Qualifications #3-#4 (medal winners): Higher classification
- o Qualifications #3-#4 (medal winners): Lower classification
- Qualifications #5-#6 Higher classification
- Qualifications #5-#6 Lower classification

## **Additional Proposal**

If a state-qualifying player/team did not play at the previous state tournament, but a lower district finisher in the same event in that district would be seeded based on the above criteria, then the player/team in question would receive the seed of the lower district finisher.

Example: Player/Team A finishes ahead of Player/Team B in district. Player/Team A did not play at state the year before, but Player/Team B did and would receive a seed based on the seeding criteria. Then Player/Team A will receive the seed that Player/Team B would have earned.

The three major areas of high school activities are weighted equally in determining recipients of the award.

- The Academic Component is based on the varsity team's cumulative GPA as submitted on the State Academic Champions application for all IHSAA sponsored sports/activity programs.
- The <u>Performance Component</u> is based on place of finish at IHSAA-sponsored state championships and activity program competitions.
- The <u>Citizenship Component</u> is based on a school's self-evaluation of their citizenship/sportsmanship activities as submitted on an itemized form. Deductions are made by the IHSAA for player and/or coach unsportsmanlike ejections and also for unsportsmanlike school behavior at state tournaments.

In addition to the primary awards, schools that score 90% on the Citizenship Component and have no player/coach ejections throughout the year or incidents of unsportsmanlike school behavior at state tournaments will receive an "Award of Excellence" certificate. The 2024-2025 Award of Excellence schools are Mountain View, Owyhee, Kuna, Bonneville, Century, Twin Falls, Wood River, Kimberly, Sugar-Salem, Snake River, McCall-Donnelley, Cole Valley Christian, Malad, Declo, Ririe, Rockland, Carey.

Our girls' basketball program would like to respectfully request your consideration in allowing our team to petition from 5A to 6A division (mid-cycle) for the upcoming year. We believe this adjustment is necessary due to our current situation, which I will outline below, and we are confident that this change would benefit not only our program but also the broader basketball community.

As you are aware, Middleton High School has a strong tradition of promoting athletic excellence, teamwork, and sportsmanship. However, recent circumstances have presented unique challenges that have significantly impacted our ability to compete effectively in our current division. These challenges include:

- 1. An ongoing concern regarding frequent requests from fellow Athletic Directors and school principals to alter our team's style of play in order to limit the margin of victory during athletic competitions. - 2. We believe that placement in a more appropriately competitive division would better serve the developmental needs of our athletes and foster a more equitable and challenging environment for all teams.
