CONSENT AGENDA

Chad Williams provided an overview of the financial report, noting that since it is the beginning of the year, there is limited information to present at this time. He highlighted cell B20, "Officials Cards," where the total currently stands at \$18,000, which he pointed out as being relatively low. Aside from this item, he indicated that the overall budget is on track and progressing as expected, with no significant updates given the early stage of the fiscal year (Pages 15-20).

A motion was made to approve the consent agenda which include the Balance Sheet, Financial Report from July 1st, 2025, to September 12th, 2025, and the IHSAA Board of Directors actions via phone or email.

REPORT ITEMS

YEA

Julie Hammons reported that the YEA fund is holding steady at this time. She noted the addition of a new board member in District 4, Nick Popplewell, who represents one of the IHSAA's sponsors, First Federal Bank. Popplewell will be joining the upcoming YEA meeting on Monday. Julie added that further details, including any actions taken by the board, will be provided during the December board meeting.

Marketing

Chad Williams provided an update on the five-year ball contract signed with Baden in the spring of 2025. He noted that the balls have already been shipped, and schools should be receiving them shortly.

Officials

Chad Williams explained that he met with the rule's interpreters and commissioners, and one of the main messages they asked him to share was their appreciation for the support they've received. They noted that waiving the fees for the first 2 years, as well as adding the activity cards, has had a positive impact on officials across the state.

Board Committees

- **State Tournament**
 - **Esports Proposal**- The Esports Proposal was added as a discussion item and will be addressed later in the meeting (Pages 19-28).
 - **Tennis Seeding**- The Tennis Seeding Proposal was added to the agenda as a First Reading and will be discussed later in the meeting (Pages 29-31).
 - **Fall Tournaments**
 - **5A Volleyball Play-in Site**-The 5A Volleyball Play-in Site was added to the agenda as a Final Meeting and will be discussed later in the meeting (Pages 32-33).
 - **3A State Boys Basketball**- The 3A State Boys Basketball Tournament has traditionally been held at Capital High School. With Vince Mann stepping down from overseeing the tournament at the Ford Idaho Center, Capital's Athletic Director, Jason Willer, will be taking on the responsibility. As a result, the 3A tournament will now shift locations and be hosted at Meridian High School.
 - **Golf Course Payment**- Julie Hammons shared that the state tournament committee has been discussing concerns raised by golf courses regarding the amount the IHSAA pays for use of their facilities during state tournaments. Currently, the payment is around \$1,200, which has created challenges for the courses hosting events. She noted that this issue is likely to come up in future meetings and emphasized that it may be time for the IHSAA board to take a closer look at the financial commitment being asked of the courses and how to better address it moving forward.

- **Legends of the Game**

- **Selection-** The committee met and discussed their selection for this year's Legends of the Game. It will be announced and voted on later in the meeting.

Section 7/8 Conference

Chad Williams thanked everyone who attended the Section 7/8 conference and asked attendees to share their experience. Brady Dickinson shared about how he valued hearing about the challenges other states are facing, noting the similarities to Idaho's, and shared that many states are exploring creative approaches to classifications and appeals. Jan Bayer highlighted that in some states, classifications only shift in football, which she found interesting, and she also noted the wide variety of transfer policies across different states. Mike Federico reflected on a presentation he attended, explaining that attorneys in California view multiple transfers from the same school as a red flag—particularly when groups of students transfer together—and emphasized the importance of being alert to that pattern.

Julie Hammons talked about her time, and suggested considering Montana's rubric for football classification petitions, which is data-driven and straightforward, as a possible model for the future. Chad Williams concluded by introducing the idea of creating a one-stop shop for transfer paperwork, citing an Executive Director who had successfully implemented the system, and noted that IHSAA plans to meet with them to explore how a similar approach could be adopted.

Hall of Fame Review

Julie Hammons discussed the financial commitment of the Hall of Fame banquet, noting that the event operates at a loss even with ticket sales. She explained that the only way it remains possible is by partnering with the IASA to use the banquet room after them, but even so, the banquet results in about a \$20,000 deficit. The only outstanding expense is the video production bill, which is approximately \$1,400. Julie noted that this year's event was comparable to previous years and closed by thanking everyone for their help and support (Page 34).

Board Terms & Board Make-up

Chad Williams reviewed upcoming board term changes, beginning with Jan Bayer, who is completing Dena's Naccarato's term and is now officially beginning her own. He noted that Rob Sauer's three-year term is up for renewal, which will require a representative from District 3. Mark Kress is completing his first three-year term and will be up for election, so District 5 will need to select a representative. Tonia Burk and Hiroshi Fukuoka are both finishing their terms, and nominations will be required to replace them. Chad also mentioned that Burke Davis, who represents the principals, had previously completed Curt Randall Bayer's term and has now officially finished his first full term. Burke is eligible for renewal, which would provide representation for District 6.

Chad reminded the board that the bylaws were recently changed to allow for broader geographical representation across the state. He noted that the only two members who will not be returning are Hiroshi and Tonia, whose replacements must come from Districts 1, 2, 3, or 4, though both cannot be from District 3. This adjustment will begin in August 2026 (Page 35).

District President and Secretaries Meeting

Chad Williams reported on the recent District Presidents and Secretaries meeting, noting that while the group considered holding the meetings via Zoom, they ultimately preferred meeting in person. He explained that the sessions gave them a chance to review new rules, better understand their responsibilities, and provided valuable time to build stronger working relationships (Pages 36-42).

Online Rules Clinics Data

Chad Williams noted that the attached data shows attendance figures from the recent online Rules Clinics and mentioned that, while the group prefers face-to-face meetings, scheduling can sometimes be challenging. He also shared that the attendance numbers are consistent with previous years.

Football Bracketing Meeting

Jeremy Burgess reported that the Football Bracketing Meeting will be held on November 17, 2025 at 9:00 a.m. at the West Ada District Service Center, 1303 E Central Dr. Meridian, Idaho.

Director's Committees

- **Transfer Rules Review-** Chad Williams noted that the committee has met, and it will be discussed on the agenda later.
- **Track Proposals-** Chad Williams reported that the committee has met once to review and discuss the proposals, with another meeting scheduled in a few days. He noted that a recommendation is expected to be presented by the December meeting.
- **100-Year Anniversary-** Julie Hammons thanked the committee members for their efforts and shared that their next meeting is scheduled for October 7th. She explained that members will be reaching out to schools to collect historical content from their archives, such as photos, which will be scanned and used during state tournaments on video boards and in the tournament program when possible. Additionally, they will contact schools to identify any famous alumni and, if they do, ask for a message from them to feature on the IHSAA's social media channels.
- **Sports Medicine Advisory-** Chad Williams expressed his appreciation for the committee and their expertise, noting that they are currently in the process of updating the physical form, as it was a little outdated. He added that the updated form is expected to be completed by next year.
- **Classification Committee-** Chad Williams reported that they haven't met yet, but plan to before December.

Rules & Regulations

- **Rule 8-11 and Rule 12-** Julie Hammons discussed the topic of outside competition and whether schools would like to continue having restrictions in place, noting that most schools support limiting participation during the season. She explained that this issue is becoming more common in tennis and golf and is now spreading to other sports. Currently, Rule 12 is very specific about how approvals are granted and does not allow broad approvals, but the board is seeing increased pushback and appeals when requests are denied. Julie emphasized the importance of understanding how approvals are being reviewed. She noted that including this topic on the agenda serves two purposes: first, to ensure the board understands how Rule 12 is being applied, and second, to capture feedback from member schools that may feel the restrictions are too limiting. She encouraged anyone with feedback to contact the office (Pages 43-52).

ACTION ITEMS-FINAL READINGS

Wrestling in Moscow, Venue Cost, Coaches Survey , U of I Letter (Security & Tickets)

Shawn Tiegs reported that discussions with the University of Idaho regarding the details of hosting State Wrestling are still ongoing. He noted that he and Chad are prioritizing this topic for the December meeting. No action was taken (Pages 53-57).

Rule 2-5 Representation

Mike presented an overview of the Rule 2-5 Representation proposal, noting that the directors rewrote the rule to reflect a new era and how state tournaments are represented. He emphasized that everyone should review the proposal in detail, as detailed videos and district-level discussions will follow to explain the specifics. Key changes highlighted include the adoption of a five-classification model with a 40% allocation, along with the alternate 6A proposal. Representation rules were clarified: in a two-school conference, both automatically advance, while a three-school conference earns an automatic bid with a win; remaining teams in a six-team conference will be determined by MaxPreps.

Mike noted that play-in game details, including site and time, are set by athletic directors, though dates and rankings will be provided. Rules for 2-5-2 and 2-5-3 were discussed, with 2-5-2 noting that individual sports will still use the representation that has been used for them previously. 2-5-3 notes that there will be a max of 12 teams in the state football tournament that will go into effect next year. Petitioning allows for potential one-team leagues, requiring a top-8 ranking for state qualification. The ranking process timeline was also adjusted from Saturday to Tuesday, with play-in matchups released the Wednesday morning, prior to Saturday's play-in games, with a \$1,500 fine for failing to submit scores on time.

For 4A and 5A, districts with two teams automatically advance if ranked in the top 8, while district winners not in the top 8 enter play-in games. Half-berths will go to play-in games. Julie noted that the summary is generic, as models differ by sport; directors will provide sport-specific training. Chad emphasized the need to know if any districts were going to combine by the November 1 deadline to ensure proper representation. Mike added that many 6A schools are petitioning, and adjustments will be made in MaxPreps to fill available spots, with district games counting toward rankings and district tournaments shifted back one week (Pages 58-61).

ACTION AGENDA-FIRST READINGS

Rule 13-3: Physicals for Out-of-State Transfer Students

The suggestion to update Rule 13-3 came from the sports medicine committee, and the verbiage change now recognizes out-of-state physicals.

Rule 13-3.4: Proposed

Physicals are required in the 9th and 11th grade year. Students who have a physical in their 10th grade year must have another for the 11th grade. Students will not be required to take an additional physical examination during the 10th and 12th grades unless:

1. The physician recommends the student have an additional examination.
2. The parents request an examination in the Interim Questionnaire.
3. Affirmative answers on 1-10 of the Interim Questionnaire indicate a possible need for a repeat physical examination.
4. A student ~~has transferred to Idaho~~ from another state or country but submitted a physical form that does not meet IHSAA participation standards.

Tennis seeding proposal

Mike reported on the tennis seeding committee's recommendation to review the criteria to ensure consistency across classifications and equal representation for all athletes. The proposed changes affect qualifications 3, 4, and 8 in both singles and doubles, giving added weight to the previous year's top-four state finishers to help ensure the best players are seeded appropriately. Initially, the final criteria was changed from best record with at least 10 matches to using the Tennis Reporting ELO rating system, similar to TrackWrestling. However, after surveying coaches, feedback showed they did not support the use of ELO ratings. The committee asked that ELO be removed from the proposal and the best record criteria reinstated. Mike will rewrite the proposal accordingly before it is brought forward for a second reading (Pages 29-31).

DISCUSSION ITEMS

- 1. Rule 8-14: Transfer Rule Review Committee Proposal-** Chad discussed the Transfer Rule Review Committee, noting that it originated from HB 237. He shared that he had assured the legislature a committee would be formed to review the transfer rules, and that group has been meeting frequently. The committee's recommendation was to leave the rules as they are. However, if a change were required, the only adjustment they would support would be to allow one free transfer that has to occur during the summer prior to junior year, before the fall no-contact period.

Brady Dickinson commented that the current system has served well and should continue, emphasizing the need to stand firm on the existing rules. Randy Lords encouraged the office and Chad Williams to continue working with the legislature. Brady also noted that if legislation does move forward, it will require a collective effort to respond effectively (Page 65).

- 2. IHSAA 5-Year Tournament Calendar Proposal-**Mike reported that the Board asked the office to review the athletic calendar, specifically how sports seasons overlap and vary in length. The question of whether the school year should be extended to accommodate season lengths was considered, but the consensus was not to extend the calendar.

The directors discussed ways to make the seasons more equitable from sport to sport. It was noted that athletes often do not get breaks during their seasons, and certain sports—such as cheer, dance, and wrestling—overlap significantly. Historically, fall sports had staggered start dates because their tournaments occurred at different times. Adjusting those dates now would result in one less week for each activity. The directors decided that they will continue to gather more information and have more information on the proposal at the December meeting (Pages 66-67).

Brady Dickinson moved, Jan Bayer seconded to move the IHSAA 5-year Tournament Calendar Proposal to the Action Agenda as a First Reading for the next Board Meeting.

- 3. Rule 10-1-2b: Annual Background Check, Research-** Chad William discussed Rule 10-1-2b regarding background checks on officials. He questioned the necessity of conducting them annually, noting that other states handle this differently. Legal counsel recommended conducting checks every 3–5 years, with language requiring officials to self-report any legal trouble in the interim. Chad recommended moving to a 5-year cycle.

Randy Lords moved, seconded by Raini Hayden, to advance the Rule 10-1-2b verbiage changes to a First Reading, with background checks conducted every 5 years and added language requiring officials to self-report any legal issues (Pages 68-69).

- 4. Esports Proposal-** Chad Williams presented the Esports proposal and explained that he created a template schools could use if they wanted to submit one. The State Tournament Committee recommended moving the proposal to discussion. Gericke Kohn from the Idaho Esports Association provided background on the activity, noting that Esports participation is already strong, with more than 60 high schools and 1,200 students involved last year, and several students earning college opportunities.

He shared that the Association follows IHSAA eligibility requirements, runs a 7-week regular season with a 3-week postseason, and holds a state tournament. The event has previously been hosted at Boise State but has since outgrown that venue and is now looking at the Mountain America Center. While participation fees have not yet been charged, sanctioning would provide financial support and help principals better understand the benefits, making them more likely to create teams.

Spencer expressed hesitation about sanctioning due to potential expenses and the lack of projected revenue, emphasizing the importance of first gauging school interest before moving forward (Pages 19-28).

Testimonial and comments:

Julia Grafft - Wood River High School - Principal I love the idea of Esports being part of the IHSAA. It caters to students who don't always participate in the other IHSAA-sanctioned activities and has proven to be connected to a number of viable post-secondary options/fields. Please make it part of IHSAA!

Johnny Hullinger - Middleton High School - Principal - This would be an opportunity for the state to reach a group of students who have not previously been involved with state-level competitions. This would bring greater legitimacy to esports and provide more opportunities to more students.

Matt Harris - Ririe High School - Athletic Director - I am in support of this request if, and only if, the IHSAA and its member schools deem this financially feasible. There is great demand for the existing dollars within the IHSAA and adding Esports would not add to existing dollars.

I would like to comment that the IHSAA uses the word "sanctioning" differently than "sponsoring". In the IHSAA, "sanctioned" means they approve of a sport/activity being played, but "sponsored" means that the IHSAA also conducts/manages a state tournament in that sport/activity. For example: up until last year, all state baseball tournaments were "sanctioned" by the IHSAA, meaning they set the rules and guidelines for play, however baseball was not "sponsored" by the IHSAA, meaning that the IHSAA did not host nor was in charge of a state tournament for baseball (it was ran previously by baseball coaches in each classification).

If the goal of the IEA is to achieve "sanctioning" with the IHSAA, well sanctioning won't do you much as you already have an association that seems to run well and has rules and regulations. Sanctioning won't do much for you. However, if you want the IHSAA to "sponsor" Esports and conduct/manage the Esports state tournament, then this petition makes more sense because then they would

I would also add that the IEA would need to be aware that if the IHSAA sponsors Esports that the IEA will have to hand over the reigns of this activity to the IHSAA and that the IEA would play a much smaller role (or possibly none at all).

One other thing to consider would be any sort of budget considerations for Esports being added to a school's athletic/activities department, including cost of equipment, registration fees, state tournament expenses, etc. While I believe that I could probably figure it out in my athletic department, many other schools may not be able to.

I can't tell you how many students have been motivated by this opportunity and have found their niche from Mr. Anderson's amazing energy. Having said that, he has set it up to be sustainable even after he moves on. Coupled with his NerdFest club, the E-sports team extension is one of the most critical programs we offer.

Andrew Wray - Burley High School - Principal - I helped get the league started and saw what a positive impact it had on students in Idaho and Burley High School specifically. Our coaches and programs need support from their local districts, and if the only way to make that happen is to get sanctioned by the IHSAA, then I am all for it!

Heather Asbury - Capital High School - Teacher/Coach I have had 2 students so far in just 2 seasons get offered scholarships to BSU if they decide to play on their esports teams!

Dalton Hawkins - Sandpoint High School - Teacher/Coach I have been involved with esports at our school since 2017 and have seen the impact that it has on our students. We have become the first place that many new students are sent to because so many respond to "What do you like to do?" with "I play video games." The best thing for these students and the hardest thing for my program is that so many students come in, often without friends. They then make friends with others who have a similar interest and then go on to do other activities together. Sanctioning would bring a sense of legitimacy to players and teams, something that parents could look at and know it's not just some club at the school but rather an actual activity with the same amount of legitimacy as cheer, drama, dance, music, debate, and speech. I would prefer if IHSAA went with Idaho Esports over some outside organization, just because schools are already onboarded with their platform, and they have players' best interests in mind rather than investors or profits. They are easily the most affordable without being questionable about how they keep their program going.

Marcelita Loosli - Wood River High School - Teacher/Coach As a teacher and Esports club advisor, I've seen firsthand the positive impact competitive gaming has on students. I have watched my team develop into a cohesive group of players who are highly committed to their games and their teams. Unlike other sports, my team begins practicing in September and doesn't quit until after the State tournament in May. This is an example of the dedication that these students have to our team. Including esports in the Idaho High School Activities Association would validate the hard work of these students and recognize it as the legitimate, competitive, and educational activity it truly is.

Brian Blakeley - Vallivue High School - Teacher/Coach Esports has been an important program to the students who have become involved in it. Our esports program reaches and includes students who aren't involved in other school activities and brings them together with a variety of involved students at all grade levels. It has been beneficial to those involved.

Mitch Young - Burley High - Teacher/Coach Esports is a great way to find students who need a place to feel included. A place where students can make friends and get out of their houses to enjoy teamwork. A place where students who can't play a traditional sport can be included.

David Hopwood - Highland High School - Teacher/Coach "I want everybody on our team to have a foundation that's not football, because football will let you down. At some point for everybody, money, fame, it will all let you down" (Spencer Danielson, BSU Head Football Coach). I believe that Esports is the foundation that many students need and want to be a part of their school and its culture. I have seen this have a positive and important impact on many of my own students. This has given them a home, a place where they can share their interests, make friends, and compete. I have seen many of my students grow into becoming leaders, learning to communicate, work as a team, and develop strategies for success. We have had 2 students who were offered and accepted scholarships to Idaho State University Esports and currently play for their esports teams. My students look forward to competing each year, knowing they are playing against other students across the state. Esports offers a unique experience, does not have physical barriers, and allows students of various backgrounds to come together as a team and compete. It's been amazing to provide this experience and opportunity for students who have been looking for a way, a foundation, to be involved in their school community.

Brad Wallace Ed.D. - Highland High School - Principal ESports has been offered at Highland for the past few years as a club. It continues to grow in popularity and diversity. This club has had a major impact on our school. It has motivated struggling students who now have eligibility requirements to seek help and work harder on their academics. It has increased social skills for many of our students who have not had the opportunity to be a part of a team, learn leadership skills, learn how to work with others, and learn self-discipline. Students who participate also learn how to compete, how to win, how to lose, how to work towards a goal, and how to respond to everything that is involved in competitive situations. Participating in a competitive event

teaches lessons vital to life. Finally, ESports can provide students with opportunities to pursue post-secondary goals that students may not have otherwise.

Danner Hill - Middleton High School - Coach As a previous student at Middleton High School, I competed in this program for 3 years, and now, after graduating, I have continued to stay a part of this program to help continue this amazing opportunity for high schoolers. I truly believe this competition provided by the IEA is something special and is something that can propel these students into their future careers.

Archie Wright - Borah High School - Coach We are excited that esports is headed in the right direction industry-wide. Borah High has had increased awareness with esports and has increased the size of student participation from last year. Esports is giving students new scholastic opportunities. Our esports team visited BSU's Science Department and Esports Arena on a school field trip recently. Esports will gain more traction as a sanctioned sport. I believe esports will be a natural and positive addition as a new high school sport. Opportunities for more public awareness and community support will be welcomed as a result.

Janel Fraley - Capital High School - Coach Esports would be a great additional sanctioned activity for students!

James Gaydusek - Shelley High School - Coach, IT/Network Admin - I have seen firsthand how this has helped students engage and participate and have changed how they interact with their fellow classmates. There were some students who could not do physical sports or did not want to due to social issues, but with esports, they opened up and began engaging with other students and were encouraged to participate no matter the learning curve. These students had made a sudden 180-degree turnaround and were even noticed by some of their teachers and classmates that they are more productive and responsive in classes ever since the program was introduced in our district.

Joe R. Anderson - Mountain Home High School - Teacher/Coach - As the advisor for a group here at MHHS, known as NerDFest! we have been active participants in online gaming, with board approval, since 2015. We have taken part in several local and state esports competitions, and we were one of the first schools to be part of the Idaho Esports Association. Many of our students have gone on after graduation with a greater sense of purpose and focus thanks to being a part of our team. In joining IHSAA I feel it would only expand the sport faster and further in our state as well as the nation by linking with the collegiate system as well as the professional worldwide leagues as well.

Korbin Cook - Thunder Ridge High School - Teacher/Coach - In today's digital age, esports has emerged as a rapidly growing phenomenon, captivating millions of young people worldwide. It's time for high schools to recognize esports as a legitimate activity, offering students a new avenue for growth, competition, and skill development.

Esports fosters critical thinking, strategic planning, and quick decision-making. Players must analyze complex situations, adapt to changing scenarios, and work effectively in teams.

Unlike traditional sports, esports is accessible to students of all physical abilities, promoting a more inclusive school environment.

The booming esports industry offers various career paths, from professional gaming to event management and game development.

Many esports titles relate to STEM fields, encouraging students to explore technology and computer science.

COMMENTS FROM SURVEY/EMAIL

I am not in support of the ELO rating being a component of the ranking system at all. I do not think that it is equitable for all schools as the strength of schedule for two different schools in the same conference may be different. We may want to play tougher schools but have a hard time getting them on our schedule. The ELO rating also may have some influence from tournament results for tournaments that are not openly available to all schools. I know that it was the lowest in the hierarchy ranking on the proposal, however, if the ELO rating is allowed, it may be prioritized differently with future actions.

My problem is that that Tennis reporting sucks. It doesn't take into account the team position seeding (ie. # Boys Single 1, 2, 3, etc) We had a boy who was undefeated in Boys singles #3 and ranked almost as high as our Boys #1 who can't come close to beating him (usually 6-1, 6-0). Another example, our #1 beat another #1 the last 2 times during the season yet he was ranked higher than our #1. I just think the Tennis reporting is using a broken scoring mechanism.

*The ELO is skewed for those of us who play schools from out of the state. Where we live, we have to travel hours for competition. We play numerous Washington schools to fill our schedule. Clearly not a level playing field.

*Tennis Reporting response:

Kind of true---kind of not true

It has very minimal effect on the ELO playing out of state teams (WA does have some teams who use site), but if they are playing teams who don't those players will have a baseline ELO----which could potentially not allow them to improve their ELO because they are not playing/beating kids with higher ELO numbers, but same can be said about a loss to a kid with no ELO.

I believe the match counts are minimal-so the effect is minimal, but their competition if they play people who don't have results won't hurt or help them much when it comes to ELO----their numbers for a win or a loss VS a kid who has a baseline ELO won't be affected much.

Warm-Up Time for Matches

There will be a **maximum** of twenty minutes for pre-match warm-up between matches. The timer should start the clock 20 minutes prior to the start of the contest. The time schedule for the pre-match warm-up shall consist of the following 20-14-7:

1. 20-17 minutes: Teams can share court for warm-up time
2. 17-14 minutes: Coin flip to determine the serving and receiving teams. Pre-Match Conference will take place at the score table and should include the head coach, team captain and officials
2. 14-7 minutes: Visiting team (low seed) practices on the full court including net play and serving
3. 7-0 minutes: Home team (high seed) practices on the full court including net play and serving
 - * No off contest court practice while opposing team has the court for warm-up.

The warm-up period may be limited to 15-12-6 at the discretion of the tournament manager due to schedule requirements. If this becomes necessary, the periods shall consist of:

1. 15-12 minutes: Coin flip to determine serving and receiving teams. Pre-Match Conference will take place at the score table and should include the head coach, team captain and officials.
2. 12-6 minutes: Visiting team practices on the full court including net play and serving
3. 6-0 minutes: Home team practices on the full court including net play and serving
 - * No off contest court practice while opposing team has the court for warm-up.

Each tournament site has an area designated for team stretching prior to the start of the pre-match warm-up period. **Teams will not be allowed on the playing court until the clock is started for pre-match warm-ups.**

Official Ball

Baden Perfection VX5EC-220A (blue, grey and white) is the official ball of the IHSAA State Tournament.

Bench Protocols

Team benches will be determined by the home team. Teams will not switch benches unless the officials determine there is a clear and distinct disadvantage, then teams would switch sides.

Warm-up and Practice Between Sets

Teams will not be allowed to use the net for practice between sets. The ball may not cross the net. The number of participants at any practice or warm-up, shall be limited to the number of participants allowed in uniform (15).

Number of Participants/Coaches/Support Personnel

At all play-in and state tournament matches, teams are limited to fifteen (15) students in uniform during warm-ups and at the start of the contest. Violation of this rule will result in the school being assessed a maximum fine for dressing more than the approved number of players at a state play-in or tournament match with forfeiture of the match if excess numbers play. All classifications will be allowed three coaches and three support personnel to be admitted without an IHSAA card or tournament pass. Any coaches or support personnel exceeding that number must have either an IHSAA card or purchase a tournament pass.

Team Match Limitation

No team or individual shall play more than 16 regular season dates.

1. A maximum of 8 dates tri-matches. Any school playing two schools on the same date must count that competition as a tri-match.
2. Two dates may be tournaments (more than 3 schools involved).
3. A team may substitute one additional tournament. A school desiring to play in 3 tournaments may only play on 15 dates.

Rules for tournament play:

1. A tournament may be of any format.
2. A tournament held on Friday after 1:00 p.m. and Saturday will count as one date or one tournament.
3. A two-day tournament starting prior to 1:00 p.m. on Friday will be counted as two of the sixteen allowable dates.
4. Total number of sets throughout the tournament will not be counted.

Individual Match Limitation

The athlete is permitted to play on **only 16 regular season dates**. Athletes may play in a sub-varsity and a varsity match against the same school on the same day providing the individual does not exceed five sets in 6A, 5A, 4A and 3A and seven sets in 2A and 1A. Athletes in all classifications may play in a post-season tournament (Freshman, Sophomore, JV) and then participate in the varsity district tournament.

A contestant who exceeds the limitations of regular season participation will become ineligible for district, state or any other additional IHSAA sponsored competition of that sport.

Rules

All contests will be played under National Federation rules. Rule books and case books are to be picked up and signed for by the school representative at the district rules clinic.

IHSAA Match Details

1. All varsity matches shall be best 3 of 5 sets.
2. Sets shall be played to 25 points, no cap, win by 2 points.
3. Fifth and deciding set shall be played to 15 points, no cap, win by 2 points.
4. Home team selects its team bench upon entering the facility, and visiting captain shall call the toss. If necessary, prior to the deciding set of match, home captain shall call the toss.
5. Each team shall be allowed 2 time-outs per set, with a total of 10 time-outs if 5 sets are played.
6. 18 substitutions
7. Use of the libero has been approved by the IHSAA Board of Directors. See the NFHS Volleyball Rules Book for specific applications for using the libero.
8. Season tournaments, pool play and tri-matches can play 2/3 to 25, no cap, win by 2 points; the 3rd set to 15, no cap, win by 2 points.
9. State tournament will use the 3 of 5 format.
10. Sub-varsity matches may use the 2 of 3 format.

RULE 8 - INDIVIDUAL ELIGIBILITY

These rules determine a student's eligibility to participate on a school athletic team or in specific competitive activities.

NON-SPORT ACTIVITY ELIGIBILITY

Cheerleading

Students who participate in competitive cheer are subject to rules 8-1 through 8-15, with the exception of Rule 8-4 Amateur Status, 8-5 Awards, and Rule 8-11 Outside Competition. Members of cheer teams that do not compete must be regularly enrolled students at the time of participation. *Non-traditional students – See Rule 8-16.*

Dance

Students who participate in dance competition are subject to rules 8-1 through 8-15, with the exception of Rule 8-4 Amateur Status, 8-5 Awards, and Rule 8-11 Outside Competition. Members of teams that do not compete must be regularly enrolled students at the time of participation. *Non-traditional students – See Rule 8-16.*

Speech Arts

Students who participate in debate, speech and drama competitions are subject to Rules 8-1 through 8-15, with the exception of Rule 8-4 Amateur Status and 8-5 Awards. *Non-traditional students – See Rule 8-16.*

Music

Students who audition for All State or compete in the State Solo Contest are subject to Academic Eligibility Rules 8-1 through 8-1-5 and Enrollment/Attendance Rule 8-8-1. *Non-traditional students – See Rule 8-16.*

8-1 ACADEMIC

To be academically eligible for athletics, a student must be enrolled full-time in his/her school, on target to graduate based on State Board of Education graduation requirements and have received passing grades and earned credits in the required number of courses during the previous reporting period. Equivalency is determined by the following criteria:

- 3 classes attempted must pass all three
- 4 classes attempted must pass at least three
- 5 classes attempted must pass at least four
- 6 classes attempted must pass at least five
- 7 classes attempted must pass at least five
- 8 classes attempted must pass at least six

- a. Students participating with a cumulative GPA below 2.0 must have an academic improvement plan in place as developed by the local school district. This plan must include monitoring, additional assistance, time provided for assistance, and an appropriate timeline. (The number of students with an academic improvement plan will be reported on the Eligibility Verification Report).
- b. Being “on target to graduate by State Board of Education requirements” means: a student not having the necessary number of credits to graduate with their class through the normal school day program, must have a graduation plan that provides for receiving a diploma by the end of the summer following their senior year in order to be eligible for activity participation. (The number of students with a graduation plan will be reported on the Eligibility Verification Report.)
- c. Schools may adopt stricter academic eligibility policies.

8-1-1 Credit is granted for an approved course meeting for five periods a week, for the prescribed 18 weeks (semester) or an approved equivalent. Approved trimester scheduling is acceptable. Approval of equivalent scheduling must be approved by S.D.E. (See 8-1 to determine equivalent scheduling.)

8-1-2 An approved course is one which is taken for credit toward graduation. A college credit course that is also allowed for high school graduation is acceptable.

8-1-3 When a student from a member school enrolls in any college course, summer school, night school course, or correspondence course approved by the Idaho State Department of Education and such student desires to have the credits count toward IHSAA scholastic eligibility requirements, the student must obtain written approval from the high school principal stating that each specific course credit will be accepted and counted toward graduation.

8-1-4 An incomplete or conditional grade received at the end of a semester counts as a failure until the deficiency is removed.

8-1-5 A student must have satisfactorily completed the preceding semester/trimester and the academic eligibility requirements to be eligible for the current semester/trimester.

8-1-6 For students enrolled in an approved special education program in which the I.E.P. is the standard of measurement for progress toward graduation, the district shall verify that the student is making satisfactory progress and meeting the standards of the I.E.P.

8-2 **AGE**

A student becomes ineligible for athletics upon completion of the sport season in which he/she turns twenty (20) years of age.

8-3 **ALL-STAR COMPETITION**

8-3-1 Only those students who have completed the sport season of their senior year may participate in all-star, benefit, or similar contests. Such contests may not be held during the IHSAA sport season and must be submitted for approval by the IHSAA at least 30 days prior to the contest. All-star competitions held after the first week of June, in which only graduated seniors participate, do not require IHSAA approval. Students, parents, and coaches should examine NCAA regulations prior to participation in any all-star contest.

8-3-2 While the IHSAA allows conferences to select an "all-conference" team, the Association does not recognize any type of all-tournament or all-state selections. If school personnel participate in the selection process, they must not do so as a school representative.

8-4 **AMATEUR STATUS**

8-4-1 A student who represents a school in an interscholastic sport shall be an amateur in that sport. An amateur athlete is one who engages in athletic competition solely for the physical, mental, social, and pleasure benefits derived therefrom.

a. An athlete forfeits amateur status in a sport by capitalizing on athletic fame by receiving money, compensation, endorsements or gifts of monetary value in affiliation or connection with the student's school team, school, league, district or IHSAA (scholarships to institutions of higher learning are specifically exempted).

1. This provision is not intended to restrict the right of any student to participate in a commercial endorsement provided there is no school team, school, league, district or IHSAA affiliation.

b. An athlete forfeits amateur status in a sport by signing a professional contract in that sport.

c. It is permissible for a player to accept necessary meals, lodging and transportation if such are accepted in service rather than in money or any other material form. Examples of such events include NCAA Academies, McDonald's All-American games, USA Basketball, etc. State or district level all-star games will not be considered for this.

8-4-2 Amateur status will not be jeopardized by accepting a nominal, standard fee or salary for instructing, supervising or officiating in an organized youth sports program (school or non-school) or recreation, playground or camp activities.

8-4-3 A student may receive the benefits of participation in carnival type / luck-of-the-draw / lottery style activity that is open to the general public. This type of competition must be limited to individual type competition and not put one contestant against another.

8-4-4 A high school student who loses amateur status may apply to the Association for reinstatement in the interscholastic program.

8-5 **AWARDS**

8-5-1 A student may not receive cash of any amount or an award, playing equipment or prize, which exceeds the retail value amount of \$300, including, but not limited to, attendance at an instructional camp or all-star game.

8-5-2 A student is governed by IHSAA rules when he or she participates in IHSAA competitions. If a student competes outside the IHSAA sports season, awards are governed by the amateur governing body of that sport. If no regulations exist for that sport, 8-5-1 is in effect.

8-6 **ELIGIBILITY RULE WAIVER REQUEST**

The Board of Directors has the authority to waive an eligibility rule when, in the opinion of the Board, the rule fails to accomplish the purpose for which it is intended. This request must be completed and submitted by an administrator of the school in which the student is enrolled and will be attending. The request should include any hardship that has a bearing on the case. The order for review will be as follows:

a. The Executive Director will first consider each case after they receive an Eligibility Regulation Waiver form.

b. If warranted, an eligibility committee of the Board will consider each case after they receive an Eligibility Regulation Waiver form.

c. At the school's request, an appeal committee, consisting of Board and community members who did not hear the first appeal, will then consider the case.

8-6-1 A written notification of the decision will be sent from the Executive Director. The decision of the eligibility is final.

8-7 **ENFORCEMENT**

- 8-7-1 The administration of the member schools shall be responsible for administering and enforcing eligibility rules, and shall have the responsibility of educating and guiding students in the rules of eligibility which govern member schools of the Association.
- 8-7-2 In the event an ineligible student is discovered to have participated, the member school principal shall:
- Immediately notify the IHSAA office.
 - Send a written report to the Executive Director and the District Board of Control Secretary. The report must include the name of the ineligible student, the cause of ineligibility, dates of contests in which the student participated when ineligible, and how the error was made.
 - Declare the student ineligible for further competition until notification of a decision has been received from the Executive Director.

8-8 **ENROLLMENT / ATTENDANCE**

- 8-8-1 A participant shall be enrolled as a full-time student in the school sponsoring the team on which he/she participates unless the school is in an approved cooperative program or the participant is in compliance with Rule 8-16.
- 8-8-2 A student is entitled to athletic eligibility, providing all other eligibility requirements are met, for eight consecutive semesters after the student first enrolls in the ninth grade. The semesters of eligibility continue to be spent even though a student might not participate every semester.
- 8-8-3 No student shall be permitted to participate in more than four seasons of any one activity or more at the high school level.
- 8-8-4 No student shall be permitted to participate in more than one season per sport each school year.
- 8-8-5 Students who have not entered the ninth grade, but are taking the credit equivalency of a full-time high school student, may compete in interscholastic athletic contests against high school students. If the student does compete, however, that season will mark the beginning of his/her eight semesters of eligibility.

8-9 **FOREIGN STUDENTS**

- A foreign exchange student is a student who is under the auspices of and placed by a CSIET listed exchange program (*see list Rule 8-9-4*). Foreign exchange students may participate in the host high school athletic program provided the ***Foreign Student Transfer Form*** has been submitted and filed by the principal with IHSAA and approved by the Executive Director.
- 8-9-1 A foreign exchange student is considered to be placed with a host family when written notice of placement is provided by the exchange organization to the student and his/her parents, and to the host family.
- Neither the school the student attends nor any person associated with the school shall have input into the selection of the student.
 - No member of the school's coaching staff, paid or voluntary, shall/can serve as the host family unless the student is participating at the JV level or lower.
- 8-9-2 The foreign exchange student must possess a current visa issued by the US State Department.
- J-1 Visa: Student may be granted varsity eligibility for one year.
 - J-1 Visa Direct Placement: Student may be granted junior varsity eligibility for one year. Direct placement is reported to the IHSAA by the NFHS.
 - F-1 Visa: Student may be granted junior varsity eligibility for one year.
 - F-1 Visa, Non-Foreign Exchange International Student: see Rule 8-9-7
- 8-9-3 The foreign exchange student must comply with all eligibility requirements set forth by the IHSAA of which the school he/she attends is a member.
- 8-9-4 The exchange program must be approved by the Council on Standards for International Education Travel. Current list of approved J-1 programs can be found here: <https://www.csiet.org/j1-advisory-list/>
- 8-9-5 An exchange student from any other program is considered a transfer student and must follow the eligibility waiver process to gain eligibility.
- 8-9-6 Approved foreign exchange students are eligible for athletic competition for a maximum of one school year. The one school year includes enrollment in member schools in Idaho or other states.

8-9-7 Non-Foreign Exchange International Students

International students who are not under the auspices of, and placed by, a CSIET-listed exchange program will be ineligible for varsity interscholastic extracurricular activities for one year from the date of initial enrollment and attendance in the new school. International students must meet the following requirements in order to be considered for interscholastic athletic/activity eligibility:

- a. Must file a Foreign Student Transfer Form with the IHSAA Office and be approved.
- b. The student must possess a current F-1 visa, issued by the U.S. Immigration and Naturalization Service.
- c. The student must provide to the principal of the school he/she attends an official untranslated transcript and a transcript that is translated into English, by an acceptable agent or agency, which indicates work taken in all grades in which the student was enrolled.
- d. The international student must pay tuition to the high school he/she attends as prescribed in Section 625 of U.S. Public Law 104-208. A receipt of their paid tuition must be included in the paperwork.
- e. No member of the school's coaching staff, paid or voluntary, shall/can serve as the host family unless the student is participating at the JV level or lower.
- f. The international student must comply with all eligibility requirements set forth by the state high school association of which the school he/she attends is a member.

Non-compliance with one or more of the foregoing provisions shall render the international student ineligible for interscholastic athletics at any high school that is a member of any NFHS member state high school association.

8-10 GRADUATES

8-10-1 A graduate of any high school is ineligible for participation in interscholastic activities. Exception: A newly graduated student who participates in a spring sport will remain eligible until the end of that sport's season.

8-10-2 A student who has earned sufficient credits to graduate in less than eight semesters may remain eligible, providing the student does not actually graduate and is enrolled in and attending the high school as a full-time student.

8-11 OUTSIDE COMPETITION

8-11-1 Outside competition is not allowed and is defined as a student who competes in organized, non-school contests or events during the high school season, except as provided in Rule 12.

8-11-2 Violation of this rule will result in the following:

- a. The student will be ineligible for the next regularly scheduled contest plus an additional regularly scheduled contest per infraction. Regularly scheduled contests include: season contest, district, and state.
- b. Infractions will be reported to the District Board of Control, who may levy additional fines or penalties.

8-11-3 A second violation during the four years of eligibility by that student of the outside competition rule will result in the following:

- a. The student will be ineligible for the school team for the remainder of that sports season.
- b. Additional assessments may be possible.

8-11-4 Contests may not be scheduled to create eligibility.

8-12 PRACTICE BEFORE CONTESTS

8-12-1 Practice is defined as a scheduled physical fitness activity designed for the preparation of athletes for the ensuing sports season. Practices must be conducted under the direct supervision of a coach or supervisor who is both school-specific and sport-specific.

8-12-2 A student must have ten days of practice prior to the day of the first contest of an interscholastic athletic competition season. Football and wrestling participants must have ten days of practice in that sport. Golf is exempt from this requirement.

- a. The day of the first scheduled contest shall not be allowed to count as one of the ten days in meeting the ten-day practice rule.
- b. Athletes who have participated in an IHSAA sanctioned sport during the preceding sport season may count ten days of practice/or games in the previous sport during a three-week period prior to the first contest of the current sport.
- c. Participation in physical education classes does not constitute a practice.
- d. A student may count only six days of practice in a seven-day calendar week (with the week beginning on Sunday) towards his/her required ten days of practice.

- 8-12-3** A school team may compete in one officially sanctioned jamboree in each sport during the school year prior to the first competition in that sport.
- Jamborees must be registered through the Idaho Youth Endowment for Activities Foundation.
 - In the sport of football, a participant must have ten days of practice before they can participate in a football jamboree.
 - In the sport of wrestling, a participant must have five days of practice before they can participate in a wrestling jamboree. Wrestling jamborees must follow the take-down tournament format. The jamboree may count as one of the wrestlers ten days of practice.
 - In all other sports, a jamboree may be scheduled prior to the first contest in that sport and count as one of the ten days of practice.

8-13 **RESTRICTIONS**

- 8-13-1** Moving to another school district or school does not remove an ineligibility ruling by the preceding school or the Eligibility Committee.
- 8-13-2** A student who becomes ineligible under the rules of another state cannot remove that ineligibility simply by transferring to an Idaho high school.
- 8-13-3** Ineligible students may practice but must not appear in uniform or represent a school at a competition.

8-14 **TRANSFERS**

- A student is eligible at the school the student enters for the first time at the beginning of the ninth grade. A student who changes from one school to another school thereafter is subject to the regulation under this transfer rule.
 - The IHSAA does not recognize transfers for athletic purposes. A student who changes schools for athletic purposes will be ineligible for interscholastic extracurricular activities for one year from the date of initial enrollment and attendance in the new school.
- 8-14-1** Bona Fide Move If the parents of a student, or legal guardian in case neither parent is living, make a bona fide move to a new permanent residence in the attendance area of a school to which the student transfers, he/she is immediately eligible provided an *Athletic Transfer Form* is submitted and approved. A permanent residence is the actual physical relocation by the parents or legal guardians of a student at a new residence and termination of all occupancy of the previous residence. The change in residence must be bona fide and used as the address for utilities, registration for voting, registration for driver's licenses, registration for motor vehicles, identification cards, and the attendance zone for other school aged family members for a minimum of 365 days. For the purpose of eligibility, there can be only one residence.

Move Less Than 50 Miles If the parents of a student move to a new permanent residence within fifty miles of their home, the following documentation is required to confirm eligibility:

- Letters
 - A letter from the parents explaining the reason for the move.
 - A letter of support from the school filing the athletic transfer request.
- Proof of termination of all occupancy of previous address.
 - Escrow closing papers or official signed lease/rental termination document.
 - Evidence of termination of two utilities (e.g., electricity, water, & gas).
- Proof of physical relocation of parents/guardians & students to new permanent address.
 - Escrow closing papers or official signed lease/rental agreement document, minimum 12 months.
 - Evidence of activation of two utilities (e.g., electricity, water, gas).
 - Evidence of auto insurance with new address.
 - Evidence of paystub with new address.
 - Parents and students of driving age must provide updated driver's licenses showing the new address.

If any of the documents are not addressed, an explanation must be provided. The IHSAA Executive staff or Board of Directors may approve or deny varsity competition.

Parents, students or schools that provide false or misleading information will be subject to Rule 15-6.

- A student who transfers to a new school in advance of the parents move will become eligible the day the parents move into the new district, providing all other IHSAA requirements have been met.
- The student may remain in the old school until the close of the current semester or until the close of the school year and remain eligible at that school.
- The student may transfer to the new school at the time of moving or any time thereafter during the school year or prior to the beginning of the ensuing school year and be eligible upon enrolling in and attending the new school.

- d. If the student does not transfer to the new school within the time periods provided in (a), (b), and (c) above, the student will remain eligible at the original school but is ineligible at the new school unless otherwise approved by the school from which the student transferred and the Eligibility Committee.

8-14-2 Transfer Without a Parental Move.

- a. A student who changes schools without an accompanying move on the part of his/her parents will be ineligible for varsity interscholastic extracurricular activities for one year from the date of initial enrollment and attendance in the new school.
- b. A student who establishes eligibility outside of his/her resident school attendance zone and later transfers back to the school of his/her resident attendance zone will be ineligible for varsity interscholastic extracurricular activities for one year from the date of initial enrollment and attendance in the new school.

8-14-3 Independent Student A student who is "on his/her own" and not dependent upon parents or a guardian for a home, and wants to transfer eligibility of a prior residence, is required to attend one calendar year from the initial date of enrollment and attendance in the new school before becoming eligible.

8-14-4 Transfers between Public and Private Schools A student who transfers to, from or between a public and private school is ineligible for varsity interscholastic extracurricular activities for one year from the date of initial enrollment and attendance in the new school, unless there is a corresponding bona fide change of residence of the student's parents to the school attendance area to which the student is transferring.

8-14-5 Transfer Due to Parental Divorce or Legal Separation

- a. A student whose parents have a court decree of divorce or a court decree of legal separation (Idaho Code 32-704(2)) may establish eligibility in the school district of either parent but not of both parents. After establishing initial residency with one parent, two subsequent transfers will be permitted, one to the other parent and one return.
- b. Any transfer after two without a change of residence of that parent will require submission and approval of an Eligibility Regulation Waiver.

8-14-6 Dependent Student The eligibility of a student who moves with a family upon whom the student has been continuously dependent for at least one year and with whom the student has made a home, requires approval of the Board of Directors.

8-14-7 Non-Member School A student who transfers from a school which is not a member of the IHSAA or an association of any state must have his eligibility approved by the Board of Directors.

8-14-8 Discontinued Schools A student transferring from a closed or discontinued school is eligible for interscholastic activities upon enrollment in another school, provided the student attends a school in the vicinity of his or her home which is close enough so the student may continue to reside at home.

8-14-9 Official Change in School Boundaries A student who transfers to another school as a result of official change in the school boundary shall be eligible provided the transfer is made to the school into which boundaries the student's home has been annexed and that enrollment in that school is not later than the opening of the school year following the official change of school boundaries. The student must have been attending school in his or her home district at the time of the change of the boundaries.

8-14-10 Parent Move to Create Eligibility A student who transfers from one school to another before or without regard to a move on the part of the student's parents does not become eligible if the parents move later for the purpose of making the student eligible.

8-14-11 Waiver of Transfer A student who transfers schools under conditions which do not meet the terms of the IHSAA transfer standards may be eligible to participate in interscholastic athletics or specific activities, except varsity level, in activities in which he/she competed, tried out for, or participated on any organized club, school or otherwise scheduled team during the 12 calendar months preceding the date of transfer, provided eligibility is approved by the principals of both the sending and receiving schools and the Board of Directors, and further provided that there is no participation purpose involved in the transfer. If either principal or the Board decline to approve eligibility, the student shall be ineligible for all activities for one calendar year from the date of transfer. This rule applies to all public to public, private to private, private to public, public to private school transfers and transfers from schools outside the U.S. to any school in Idaho. A student who is eligible for non-varsity competition only is ineligible for district and state competition.

8-14-12 Waiver of Eligibility Regulation (Hardship) If a student finds it necessary to change schools due to unusual circumstances that are unforeseen, unavoidable, or uncontrollable, and wishes to participate at the varsity level of a sport or activity in which he/she tried out for, participated on or competed for, during the twelve calendar months preceding the date of such transfer, the student may apply for a hardship waiver of the transfer rule to the Board of Directors. The Board may approve eligibility for varsity competition, if circumstances warrant.

8-14-13 Definitions in Transfer Rule

- a. District — "District" refers to the school district boundaries where there is only one high school located within a school district; and to the attendance boundaries established for a high school by the district school board in which there is more than one high school.
- b. Guardianship — The term "guardianship" is not recognized for eligibility while either parent is living. If both parents are deceased, only a court appointment to a full, personal and estate guardianship is recognized for eligibility.
- c. School Attendance Area — The "school attendance area" is the official district of a high school where there is only one high school within a district or, in the case of multiple high schools within a school district, it is the defined geographical attendance area designated by the school district for that school.

8-14-14 Transfer Forms An applicable transfer form must be submitted to the IHSAA.

Athletic Transfer Form — This form is to be used for each student who transfers to a member or associate member school, moves with his/her parents, and meets all other academic eligibility requirements.

Foreign Student Transfer Form — This form is to be used for each foreign exchange or international student who desires eligibility at a member or associate member school. (See Rule 8-9)

Waiver of Transfer Rule — This form is to be used for each student who transfers to a member or associate member school under conditions that do not meet the transfer standards set forth in Rule 8-14-11. The student may be eligible to participate in interscholastic activities, except varsity level competition in activities in which the student competed, tried out for, or participated on any organized club, school or otherwise scheduled team during the twelve calendar months preceding the date the transfer.

- a. In cross country, golf, track, swimming and tennis, the student may compete at the varsity level during the regular season but shall be ineligible for district and state competition.
- b. In wrestling the student may compete at the varsity level during the regular season under the following conditions:
 1. If the student competes at the varsity level in any dual meet or dual tournament, the match shall be considered a forfeit.
 2. The student may compete at the varsity level during the regular season at an individual tournament.
 3. The student shall be ineligible for district and state competition.
- c. A student who is declared eligible for JV only, but participates at a school that does not have a JV team, will be allowed to participate at the varsity level during the regular season but will not be allowed to play in district or state competitions.

Eligibility Regulation Waiver — This form is to be used for each student who:

- a. Transfers without a corresponding move by his/her parents and desires varsity eligibility in sports he/she played in the previous 12 months.
- b. Does not meet criteria for eligibility as outlined in the Rules and Regulations.

8-15 ALTERNATIVE HIGH SCHOOL ELIGIBILITY

Students enrolled in and attending an alternative school program, who compete in IHSAA sponsored athletic programs, must comply with the IHSAA Individual Eligibility Rule.

General guidelines for students attending alternative programs:

- a. The student must comply with the eligibility requirements of the member school along with the eligibility requirements of the IHSAA.
- b. A student attending a cooperative alternative program of which his/her home school is a member would be eligible to participate in the school of his/her home (attendance) district.
- c. A student wishing to compete for another member school of the cooperative alternative program must request a waiver of the transfer rule.

8-16 NON-TRADITIONAL STUDENT

8-16-1 To be in compliance with the section of Idaho Code 33-203 that provides for dual enrollment, the following interpretation will be used:

Students who are enrolled in a nonpublic school shall be allowed to enroll in a public school for dual enrollment purposes. To be eligible for athletics or specific activities in the public school, the dual enrolled student must meet the following criteria:

- a. The student must reside with a parent or guardian in the attendance area of the public school for which the student will participate.
- b. The student must comply with the same rules and requirements that apply to any student's participation in the same activity with the exception of Rule 8-1 -Academic and Full Time Enrollment.
- c. In order for any nonpublic school student or public charter school student to participate in nonacademic public school activities for which public school students must demonstrate academic proficiency or eligibility, the nonpublic school or public charter school student shall demonstrate composite grade-level academic proficiency on any state board of education recognized achievement test, portfolio, or other mechanism as provided for in state board of education rules. Additionally, a student shall be eligible if he achieves a minimum composite, core or survey test score within the average or higher than average range as established by the test service utilized on any nationally-normed test. Demonstrated proficiency shall be used to determine eligibility for the current and next following school year. School districts shall provide to nonpublic students who wish to take state tests or other standardized tests given to all regularly enrolled public school students.

Definition of Portfolio: A collection of materials that documents and demonstrates a student's academic and work-based learning. Although there is no standard format for a portfolio, it typically includes many forms of information that exhibit the student's knowledge, skills, and interests. By building a portfolio, students can recognize their own growth and learn to take increased responsibility for their education. Teachers, mentors, and employers can use portfolios for assessment purposes and to record educational outcomes. An example of a portfolio evaluation instrument, is on the IHSAA website, idhsaa.org

- d. It shall be the responsibility of the student to make all arrangements to take the required test and provide the principal of the school with the results of the test prior to being granted athletic eligibility at the public high school.

8-16-2 Public Charter Schools that participate in approved IHSAA activities shall be allowed to enroll non-traditional students for dual enrollment. The following interpretation will be used:

- a. Public charter schools must establish an attendance zone in the public school district in which it resides. For activity purposes, the public charter school attendance zone cannot extend outside the school district in which it resides.
- b. If a school district has a public school and a public charter school, non-traditional students may dual enroll in either the public school or public charter school.
- c. If a school district has two public schools and one public charter school, the public charter school will establish its attendance zone in conjunction with the nearest public school with both schools having the same attendance zone. Example: Public School A and Public School B. If school A's attendance zone is used then non-traditional students who reside in that attendance zone may dual enroll in either public school A or the public charter school. If a non-traditional student resides in public school B's attendance zone, he/she could only attend public school B for dual enrollment.
- d. For establishing attendance zones and dual enrollment in school districts that have multiple public schools and multiple public charter schools, interpretation (c) under Rule 8-16-2 will be used.
- e. Rule 8-16-1 applies to all public charter schools for dual enrollment purposes.

8-16-3 A member school student who is academically ineligible and withdraws from school to gain athletic eligibility as a non-traditional will be ineligible for the duration of that school year and the following academic year.

8-16-4 Students who are enrolled in a private or public charter IHSAA member school are ineligible for dual enrollment in sports or activities the school offers.

8-17 CHARTER SCHOOL STUDENTS

Students enrolled in and attending a charter school that is a regular member in good standing of the Idaho High School Activities Association may participate in IHSAA athletic programs, and are eligible under Rule 8 - Individual Eligibility. The charter school must have paid required membership dues and activity fees in those activities offered by the charter school.

A student attending a charter school, that is not a member of the IHSAA, may be eligible to compete in IHSAA activities under the regulations of a dual enrolled student. (See Rule 8-16 – Non-Traditional Student)

8-18 **UNDUE INFLUENCE**

8-18-1 Definition of Undue Influence: The use of influence by any person connected directly or indirectly with an IHSAA member school, to induce a student to transfer from one member school to the other, or to enter the ninth grade at a member school for athletic competition purposes, whether or not the school presently attended by the student is a member of the IHSAA. (Recruiting)

8-18-2 The use of undue influence to secure or retain a student for competitive purposes is prohibited, shall cause the student to be declared ineligible for high school athletics for a period of up to one calendar year, and may jeopardize the standing of the high school in the Association.

8-18-3 Evidence of undue influence includes, but is not limited to, personal contact by coaches and sponsors in an attempt to persuade transfer by gifts or money, jobs, supplies, coaching, free transportation, admission to contests, invitation to attend practices and or games, free tuition or any other considerations not accorded to other students similarly situated.

8-18-4 Complaints or reports of violations of this rule will be investigated and handled on a case-by-case basis by the District Board of Control. Any school permitting such participation shall, upon satisfactory evidence submitted to the District Board of Control, be suspended from membership in the Association for a term not to exceed one calendar year.

<p style="text-align: center;">RULE 12 - PARTICIPATION IN SPECIAL EVENTS</p>

12-1 Exceptional student-athletes may participate in a maximum of three* special events where participation is by invite-only, earned by the athlete, or will create future participation opportunities without loss of eligibility provided:

12-1-1 Approval is obtained from the school principal and the IHSAA at least 30 days prior to the event.

12-1-2 The student has made prior arrangement to complete all missed academic obligations before the end of the grading period in which the absence will occur.

12-1-3 The student will miss no school-sponsored or association-sponsored event in that sport without permission of the IHSAA.

*Note: The third event request within the same season will be approved or denied based on the level of the event which must be a national-level event or equivalent.

Proposal for Hosting the Idaho State Wrestling Championships at the P1FCU Kibbie Dome in Moscow, Idaho

Executive Summary: We propose relocating the Idaho State Wrestling Championships to the Kibbie Dome in Moscow, Idaho starting in 2029. This move aims to provide a more inclusive and accessible experience for athletes, families, and fans by utilizing the Dome's superior facilities, ample accommodation options, and strategic location. We recommend establishing a rotating venue schedule that includes Pocatello, Boise, and Moscow to ensure equitable access for all regions of the state.

Rationale:

1. **Historical Significance:** The Kibbie Dome has a rich history of hosting the Idaho State Wrestling Championships with the last time being 1995, and its return to this role would honor that tradition and leverage the Dome's unique advantages.
2. **Enhanced Facilities:** The Kibbie Dome offers numerous benefits over other venues:
 - **Seating Capacity:** The Dome's larger seating capacity can accommodate more fans, enhancing the experience for attendees and supporting higher attendance.
 - **Wrestling Mat Capacity:** The Dome's larger floor space can accommodate an increased number of mats to allow for any future expansion of the tournament.
 - **Private Facilities:** Wrestlers will have access to dedicated locker rooms and bathrooms, reducing reliance on public facilities and improving comfort and privacy.
 - **University Resources:** The University of Idaho provides extensive parking options for fans, including RV spaces and nearby accommodations.
3. **Accommodations:** The surrounding area, including Lewiston, Moscow, Pullman, and Clarkston, boasts 18 hotels. Additionally, there are RV parks and a range of vacation rentals, including Vrbo and Airbnb options, ensuring ample lodging for visiting families and fans.
4. **Travel Considerations:** Shifting the championship between Pocatello, Boise, and Moscow creates a more balanced travel schedule. This approach reduces the travel burden on northern teams who currently face the challenge of traveling to the southern part of the state each year.

Benefits:

- **Enhanced Fan Experience:** With its larger capacity and better amenities, the Kibbie Dome can provide a superior experience for fans, potentially increasing overall attendance and engagement.
- **Support for Local Economy:** Hosting the event in Moscow can boost the local economy by attracting visitors to the area who will spend on hotels, dining, and other services.

Implementation Plan:

1. **Venue Agreement:** Secure a hosting agreement with the University of Idaho for the Kibbie Dome, including details on facility use, scheduling, and financial arrangements.

2. **Accommodation Coordination:** Collaborate with local hotels, RV parks, and vacation rental providers to ensure they are prepared for the influx of visitors and to promote these options to attendees.
3. **Rotating Schedule:** Develop a rotating schedule for the state championships that includes Moscow, Pocatello, and Boise, ensuring that each region has an opportunity to host the event.

Conclusion: Bringing the Idaho State Wrestling Championships back to the Kibbie Dome offers numerous advantages, including improved facilities, increased capacity, and a more balanced travel schedule. By rotating the venue between key locations, we can enhance the event experience for all participants and supporters while fostering greater inclusivity and accessibility across the state.

We look forward to the opportunity to discuss this proposal further and to explore how we can make the Idaho State Wrestling Championships a premier event for athletes and fans alike.




Wrestling Mat availability question response:

CURRENT RULE

2-5 REPRESENTATION

2-5-1 State tournament representation in volleyball, soccer, swimming, football, basketball, wrestling, track, baseball, softball and tennis will be determined for a two-year period based on a percentage of schools in that classification. Note: Representation may be altered periodically to reflect the historical representation of each classification.

- a. Representation to state competition will be determined by the percentage of the number of teams from a district or region that qualifies for state tournament competition.
- b. State play-in games should be used when the percentage of the representation between districts or regions can be more equitable.
- c. When there are three or more schools within a region or district, representation should be at least 1.5 if possible.
- d. When state play-in games are used, they should be played at neutral sites and between regions or districts of the state that would not cause unrealistic travel requirements. Note: It is considered unrealistic travel if a team cannot travel to a play-in site, compete and return to their own school in one day.

PROPOSED RULE

2-5 REPRESENTATION

2-5-1 State tournament representation in volleyball, soccer, basketball, and softball will be determined for a two-year period based on 40% of schools in each classification. Note: An alternate 6A bracket was approved.

- a. Representation to state play-in games and the state tournament will be determined by the number of teams from each district or region.
 - i. 1 school: one automatic berth to the round of 8, if the team is ranked in the top 8 of the final Idaho MaxPreps rankings.
 - ii. 2 schools: one automatic berth to the round of 8, if the team is the district champion and ranked in the top 8 of the final Idaho MaxPreps rankings. Note: A team that is a district champion and ranked outside the top 8 of the final Idaho MaxPreps rankings earns a berth in a play-in game.
 - iii. 3-5 schools: one automatic berth to round of 8.
 - iv. 6-10 schools: one automatic berth to round of 8 and one berth to a play-in game. When 40% results in an 8-team format, an additional automatic berth to the round of 8 will be awarded.
 - v. 11 or more schools: one automatic berth to round of 8 and two berths to a play-in game. Except when 40% results in an eight-team format. When 40% results in an 8-team format, additional automatic berths to the round of 8 will be awarded.
- b. Remaining berths will be filled using the next highest-ranked teams according to final Idaho MaxPreps rankings.
- c. State play-in matchups will be determined by the final Idaho MaxPreps rankings.
 - i. Higher seed will host and manage the contest.
 - ii. Officials are assigned by the host district commissioner.
 - iii. Financial protocols
 - The host school pays all expenses and covers any financial losses.
 - If gate revenue is sufficient, after expenses are paid, the host school will reimburse up to 100% of the visiting school's travel costs.
 - Additional revenue will be split 50/50 between schools.

Note: If there is a substantial gap in MaxPreps rankings and overnight travel is necessary, the IHSAA strongly advises bypassing the play-in game and advancing the higher-ranked team. The final decision rests with the traveling team's local school board and/or school administration.

2-5-2 State tournament representation in swimming, wrestling, track, and tennis will be determined for a two-year period based on a percentage of schools in that classification.

2-5-3 State tournament representation in football will be determined for a two-year period based on maximum number of 12 teams per classification.

2-5-4 State tournament representation in baseball will be determined for a two-year period based on 40% of schools in each classification including regional qualifying tournaments.

Note: District representation will be guaranteed for all sports and activities, with each district receiving at least one play-in game opportunity. Representation may be altered periodically to reflect the historical representation of each classification. NOTE: Single district teams must meet criteria in rule 2-5-1.

CURRENT RULE

Transfer Rule Review Committee Proposal (September 2025)

IHSAA Board of Directors,

The Transfer Rules Review Committee consists of twelve individuals, with two representatives from each activity district in Idaho. Members include parents, trustees, activity directors, board trustees, assistant superintendents, and superintendents. Between April and September 2025, the committee met. During this time, they examined transfer policies from across the United States, engaged with legislators, explored a wide range of options, and ultimately crafted the proposal outlined below.

The committee remains concerned about the potential unintended consequences of changing the current IHSAA transfer rules and believes the existing rules best serve the original purpose of helping maintain a fair, equitable playing field.

These existing rules are designed to:

1. Protect the integrity of educationally based extracurricular activities.
2. Maintain a fair, equitable playing field.
3. Keep focus on academics while safeguarding opportunities for all students.
4. Promote school and team unity.
5. Uphold the community-based nature of high school sports.

Current Rule

1. In 9th grade, students establish athletic eligibility by enrolling full time and participating in a tryout or practice.
2. To transfer, IHSAA Rule 8-14 applies
 - a. “JV Only” is approved via Waiver of Transfer if sending and receiving school verifying that no undue influence has occurred.
 - b. “Varsity” is approved via
 - i. Athletic Transfer (Bona fide move)
 - ii. Eligibility Regulation Waiver (hardship)

Proposed Rule

1. In 9th grade, students establish athletic eligibility by enrolling full time and participating in a tryout or practice.
2. During the summers before the Monday of the fall no-contact period of your junior year, you are allowed one free transfer by enrolling in another school as a full-time student.
3. After the fall no-contact period of your junior year, IHSAA Rule 8-14 applies
 - a. “JV Only” is approved via Waiver of Transfer if sending and receiving school verifying that no undue influence has occurred.
 - b. “Varsity” is approved via
 - i. Athletic Transfer (Bona fide move)
 - ii. Eligibility Regulation Waiver (hardship)

Clarifications

1. Rule [8-14-1](#): A bona fide move will continue to be approved and will not count toward the one free transfer.
2. Rule [8-6](#): The hardship process will continue to be an option to transfer and will not count toward the one free transfer
3. Transfers during the school year will be subject to IHSAA Rule 8-14

Proposal

New verbiage:

All officials are required to immediately report to the [Association Name] any arrest, charge, or conviction related to criminal conduct. Failure to self-report such incidents may result in suspension or revocation of officiating privileges.

Rule 10-1-2b: Annual Background Check (\$12.50/year)

1. NFHS: Each state association sets the timeline for the frequency of their background checks. Some do them annually, some do them once every other year/every three years, still others do them just when the official registers and then run a background if there are allegations of misconduct by an official. Some states allow for a “waiver” of the state association background for officials who are educators, law enforcement officers, or federal employees, due to the fact that they have gone through more stringent background checks than most online background checks offer. Unfortunately, there is no national standard for background checks since every state association is set up so differently. Most states will ask their Board of Directors/Board of Control for advice or guidance since the officials will be working at the member schools.
2. Idaho: Officials pay \$45 for registration
 - a. Background check
 - b. Rule books
 - c. NFHS education resources
3. Nevada, Utah, Oregon. Alaska: annually and officials pay the entire cost
4. Montana, Wyoming: 5 years
5. Washington: 3 years
6. Some states require officials to report to authorities if they get into legal trouble.
7. Legal Counsel?
 - a. I’ve had a chance to research this and ultimately leave it to your discretion but would recommend that background checks occur at least every 3- 5 years given the industry standards you cited. I would further recommend including additional language in section 10-1-2 that imposes an affirmative duty on the official to report to the IHSAA if they have been charged or are being investigated for any allegations or misconduct as you alluded to. We can probably borrow some language from another state but if not, we can come up with something.
 - b. The main drawback to amending the current rule and decreasing the frequency of background checks is that it gives the IHSAA slightly more exposure from a negligence analysis. This is mitigated however by the affirmative reporting duty that could be included with the amendment however.

- c. It ultimately comes down to the pro/con of how well the current rule is working and the challenges with the yearly background checks for officials. Under the caselaw, that level of scrutiny simply isn't necessary in order to meet an appropriate standard of care in this circumstance.

1. **Commissioner Job Description**—We would like to provide clarity for Commissioners and Directors, so everyone understands what those particular roles entail.

Association Reports:

Coaches—Sarah Bruce—Emails were sent to Commissioners and Schools of who the representatives were for the evaluation meetings at the end of the seasons. Reps are 1A- HSB, 2A- Idaho City, 3A-Nampa Christian, 4A-Weiser, 5A-Vallivue, 6A-Capital. Coaches Association is looking to fill the Social Director position and 6A rep.

Officials—John Cannon—Numbers look to be up for officials. He will share the directions for the new officials pass with schools. They will still have the DIII pass that will have a sticker with the updated year on it. This is his last year as President so they will go through the process of electing a new President.

Commissioner Reports:

Volleyball---Jim Bittick—Numbers are up about 10 officials with around 70 total that are active. They are working on training new officials which has been a bit challenging. They had some former officials come back. The Director is up for reelection. He will send Kimber the list of schools that didn't get their schedules in on time. They do have reports on Dragonfly to help track yellow/red cards.

Football—Scott Orr—He mentioned that he is being asked to provide officials for some Oregon schools. Commissioners will send Kimber a list of Oregon schools they are providing officials for so the Board can decide what their fee should entail. Scott went over the safety/equipment regulations and that the officials will be buckling down on this. The Federation and IHSAA are really pushing for this to be followed and officials will be looking at safety/equipment and that they are being legally worn. This was covered in the rules clinic and has been sent out to AD's. Craig also stated that if the officials can address any concerns prior to the start of the game with coaches/players that would be helpful. He has told officials to do this. They are establishing protocols for melees. It is proposed that if there is a melee, both teams will be given an unsportsmanlike conduct (off-set). If there is a second one, then they will be ejected. Scott asked who is paying for the assigning of officials in the State Playoffs. He is not getting an assigning fee for those. Swimming—Deb Hill-- West Y will not be open this fall due to a large maintenance issue that was found while doing tests prior to the scheduled opening. The meet schedule was reworked to have Saturday tri-meets at the Idaho Central Aquatic Center and Tuesday dual meets at the South YMCA. Decisions on Districts and State will be made soon. Huge thank you to Riley Jones for his help with our swimming officials! He is doing a great job.

Basketball—Brett Currin—He told his Director that they can no longer charge for jamborees. He will send a request for schedules to schools so he can start entering. They have an official arrested but hasn't been arraigned so how do they put him on leave until then. John will implement that through the code of conduct of the Third District Officials Association. Brett would like to eliminate the captains' meetings at the beginning of the game. He is not seeing engagement for purpose. It doesn't accomplish anything. Riley suggested he talk with Chad.

Wrestling--Steve Rayborn—He is looking to reinforce mouth pieces and proper wear.

Softball—Ted Pettet—He asked if other Commissioners are charging to assign middle school games. He will be assigning for middle schools this fall.

Baseball—Bob Lane—They had 18 new umpires last season and his goal is to get even more this season. Luke stated that the SIC is wanting to go back to the schedule where they don't play double headers but send JV to opposite sites for those schools that don't have lights. They are working with Bob to get that switch.

Track—Jeff Farley—There are a couple of meets that will probably go away and not come back. Eagle Island got a new director and it hasn't been user friendly. Those meets are going to Spokane because of this. It will be for the Bob Furman and Nike meets. They cannot find a different venue in the Treasure Valley to house that many cars/athletes. There will be a large meet at Eagle Island this year but nothing else. District Tournaments will also not be run there anymore as well.
