# **YEA Update**

Ty Jones reported the YEA account portfolio is near \$3.7-\$3.8 million. The YEA will distribute approximately \$130,000 to schools in the fall.

#### 2018 State Track Meet

Ty Jones reported State Track was successful and well managed but will most likely finish with a loss financially.

#### 2018 State Softball Tournament

Julie Hammons reported, despite inclement weather, State Softball was well attended and ran smoothly thanks to accommodating and responsive tournament managers and commissioners.

#### 2018 State Tennis Tournament

Mike Federico reported State Tennis facilities were fantastic. The 3A tournament was seeded for the first time and went well. Expenses were up due to an additional site for the 4A tournament, scorecards, and various facility charges. Wristbands will be issued based on the number of coaches for 2019 State Tennis.

# 2018 State Golf Tournament

Julie Hammons reported State Golf was held in north Idaho. The tournament was a great experience for student-athletes thanks to accommodating and hardworking tournament and course managers. The IHSAA is working on an improved method of reporting team scores for 2019.

#### 2018 State Speech

Ty Jones reported State Speech was held at Madison High School. Madison staff and coaches were great.

#### 2018 Administrative Workshops

Ty Jones reported the dates and locations for the Administrative Workshops Meetings have been set and are posted on the IHSAA website.

#### 2018-2019 District Rules Clinics

Ty Jones reported District Rule Clinics have been set and are posted on the IHSAA website. Schools are required to send a coach to the clinic and the IHSAA asks that veteran coaches accompany any new coaching staff member(s).

## Schools of Excellence - End of Year Standings

Julie Hammons reported the Schools of Excellence recipients will be recognized at the Annual Meeting on Wednesday, August 1.

#### **Spring Sport Concussion Totals**

Mike McHan reported on the concussion averages over the last three years. Spring sports percentages were low for tennis and golf. Baseball and softball concussion numbers were higher for 4A/5A schools. The St. Luke's Concussion Course is required for all coaches and officials on even number years.

#### **Baseball Pitch Count**

Mike Federico reported there were a number of questions and issues regarding the baseball pitch count. The pitching rules will be updated in the 2018-19 IHSAA Rules and Regulations as follows:

#### Pitching Rules

- 1. No pitcher may throw more than 110 pitches in a game or day if team is playing a doubleheader.

  A pitcher will be allowed to finish a batter if they hit the maximum limit (110 in varsity play; 85 in sub-varsity) during an at-bat, but must exit the position after the hitter.
- 2. A pitcher who throws more than 60 pitches over two days will be required to have one day of required rest. No varsity pitcher can throw more that 100 pitches over two consecutive days. No sub-varsity pitcher can throw more than 60 pitches over two consecutive days. That limit will result in one two days of mandated rest. (Note: Swing players who play multiple days at multiple levels should combine pitches thrown and use the VARSITY chart for mandated rest.)
- 3. A pitcher cannot throw three consecutive days no matter how many pitches they have combined to throw the previous two days.
- 4. Starting with the first day of practice, pitchers cannot throw more than the amount listed on the charts below. This will be for the first 30 days of practice and games. After 30 days pitchers will use the other chart.
- 5. During each contest, the home team hosts the official book. A record of pitches should be recorded with the opposing team after each full inning. Verification of all pitchers and pitches thrown should be agreed on by both teams after the game. Each school will use MaxPreps to record their own teams total pitches of each game prior to their next contest.
- Required Days rest is a complete calendar day
- EXAMPLE: (after the first 30 days of practice) If a varsity pitcher throws more that 86 pitches on Tuesday, they would be able to pitch again on Saturday. Resting on Wednesday, Thursday and Friday.
- If a school fails to report the pitch count to Max Preps from a game, the violation for not reporting occurs at the 1st pitch of the following game resulting in a forfeit

All new head dance and cheer coaches must also complete the NFHS online course "Understanding Copyright an Compliance" available at www.NFHSLearn.com.

- 4-3-1 In any athletic contest, including jamborees, any person (coach, player, staff or parent/fan/spectator associated with a member school) ejected by an official for unsportsmanlike or flagrant act will be suspended for the remainder of the contest/game/jamboree —and, will be suspended for the next regularly scheduled contest at that level of competition, and all other games/meets/matches in the interim, in any sport, at any level of competition. Note: Jamborees shall not be considered a regularly scheduled contest.
  - e.) Parents: will also be required to take a free NFHS, online course. Parents are required to take Positive Sport Parenting course, and submit a certification of completion to school administration prior to reinstatement. The course must be completed between ejection and reinstatement.
  - f.) Other Persons: (staff/fan/spectators that are not parents) will also be required to take the free NFHS, online sportsmanship course and submit a certificate of completion to school administration prior to reinstatement. The course must be completed between ejection and reinstatement.
